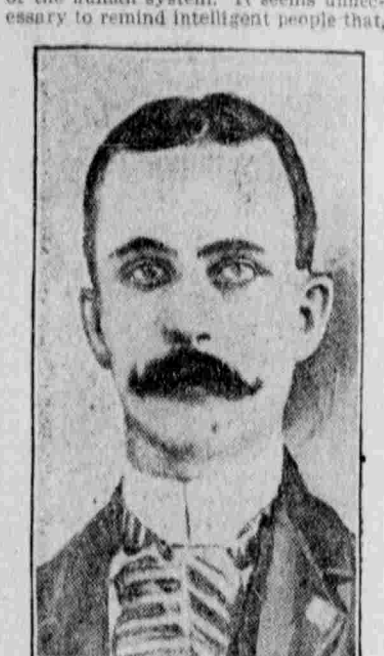

Washington, March 11.—The controversy between the American Federation of Labor and the Knights of Labor was brought into the courts again today when the Southern Expanded Metal company brought injunction proceedings against August F. Getz, Henry F. Getz and Robert Porter.

The Getzes are building contractors and Porter is the owner of an apartment house on an addition of which the workmen are employed.

It is understood that the work of the complaint was stopped March 3 by the contractors on the ground that though the work was being performed by local union workmen the workmen were objectionable because they were not affiliated with the Federation of Labor.

The complaint says that if the federation establishes its claim to prevent other local union labor from working on buildings where Knights of Labor members are employed, the committee will be stopped from the further execution of many large contracts.
