The Shipwrecked Crew of the Sea Ranger in Sitka, Alaska.

AID REFUSED BY CAPTAIN LUDLOW.

The Outrageous Conduct of a Naval Officer Reported in Washington.

New Bedford, Mass., June 23.—Three officers on the wrecked whaling bark Sea Ranger arrived at this port today from Port Townsend, Wash., by rail. One of them, John Rogers of this city, says he has been shipwrecked three times, but never before met with such outrageous treatment by white men as he and the crew of the Sea Ranger met with at Sitka, Alaska. When the thirty-six men reached Sitka they had nothing but what they carried on their backs. The authorities at Sitka would do nothing for them. They were given no money. Here, the crew of Sitka there were three United States cutters and two American men-of-war. Captain Foley of the Sea Ranger met with Captains Ludlow and McDonald and implored them to do something to help him. In protest, Captain McCollum did not make a decision in the case, but ordered the captain to find a vessel for the plaintiff.

At the very time when the business community was interested which took the silver provinces from silver, we were left in the air and prospered. The iniquitous situation as it was proved in the confusion of a depression."

Mr. Platt said he was sure that when the question was put on to the floor of Congress, more men than silver and not gold would be chosen. He said that half a million dollars were raised in England and sent over here by a confidential agent to secure the demobilization of silver. While the speaker disclosed that the money came from the Bank of England, Mr. Platt said he was unable to give the name of the man who obtained the sum.
