LEGISLATIVE.

COUNCIL .- A motion that the committee on Municipal Corporations and Town Sites, be instructed to inquire into the expediency of reporting a general bill for the incorporation of towns in the Territory, was read, and a motion to refer it to the appropriate committee was negatived.

A petition from Culbert King and 60 ethers, citizens of Kanosh City, Millard Co., was read, referred to the committee on Municipal Corporations and Town Sites.

A communication from Hon. E. D. Hoge. Associate Justice, was read and referred to the committee on revision.

An act for the incorporation of benevolent, charitable, scientific or literary institution, was taken up on its second reading and was referred to the Committee on Educa-

Conneil adjourned till 2 p.m. Friday, Jan. 29th.

House.-House met at ten a.m. A message was received from the Council announcing their passage of the House bill appropriating five thousand dollars to be expended as premiums on improved breeds of sheep, with amendments, in which the House concurred.

Mr. Maughan, chairman of special committee, to whom was referred the bill for an Act pertaining to damage done by animals, reported back a substitute bill which was ordered printed.

Mr. Taylor presented Memorial of the Assembly to Congress, endorsing the petition of Mr. Hanks and others for a grant of land on which they had established iron works.

The committee on Judiciary reported back "An act to amend an act entitled an act prescribing the manner of assessing and collecting Territorial and county taxes," in which the House concurred.

The committee on Judiciary reported adversely on the bill defining the duties of Territorial, County and Municipal officers having the management and expenditure of public funds.

Mr. Farr presented financial report of Weber county by Walter Thompson, Esq., county Clerk.

Leave was granted the Superintendent of the Salt Lake City and Wanship wagon road to introduce a substitute report.

Acting Governor Higgins notified the House of his approval of the act amending section ten of an Act defining the boundaries of counties and locating county seats.

Mr. Lyman presented communication of J. S. Gyles in relation to parts of the criminal code; read and referred to committee

on Judiciary. The committee on Revenue were instructed to make enquiry why several of the county Courts had failed to make their

financial report as provided by law. The bill amending the Grantsville city charter was reported back and passed. Adjourned till to-morrow at ten a.m.

Washington, 29.—Beaman, from the Committee on Appropriations, reported the Post Office Appropriation Bill, which was referred to a committee of the whole and made a special order for Tuesday next. The bill appropriates \$5,740,000 for the deficiencies in the Revenue and Post Office Departments, for the next fiscal year.

The Constitutional Amendment came motion to table the subject was rejected, four Republicans voting aye.

The amendment proposed is as fol-

lows: Article -- Section 1st, says the right of any citizens of the United States to vote shall not be denied or abridged by the United States or any State, by reason of race or color, or previous condition of slavery of any citizen or any class of citizens.

Sec 2nd. Congress shall have power to enforce, by appropriate legislation, the provisions of this article.

Blaine, from the committee on appropriations, reported the army appropriation bill, which was referred to a committee of the whole. The appropriations are \$49,200,000.

The next bill on the calendar being the Indian appropriation bill, Maynard moved to lay it aside and take up the Tariff bill. After some discussion the motion was rejected, 46 to 77. The committee proceeded to consider the Indian appropriation bill. The total sum appropriated is \$2,132,260, being over a million and a half less than the amount appropriated last year. After considerable discussion about the general Indian system, the committee rose without disposing of the bill.

Editor Deseret News:-Dear Sir,-I hear there is a Rumor in the city that our work is taken from us by a gang of company men. You will oblige me if you will inform Madam Rumor that she is at fault. We have no men working on our line, excepting those we have hired. We have very little of our cut to do-about thirty feet eight feet deepand have four teams and twenty odd men working on that. Shall put on fifteen more men to-morrow. There are not over 300 yards in it, and we are taking out 60 to 75 yards a day and have eight days to finish in. We have not undertaken what we can not accomplish. If the company men feel anxious about employment, there is plenty of work for them above and below our contract. Mr. Truesdell, our division engineer, feels perfectly easy about our work. With kind regards,
