Holding of a Session of Court There—  
The Union Park Mies—  
First Quarter.

SCOTLAND, June 1st.—A session of the seventh district court was commenced here today principally to consider applications for lots in the Highland townsite.

It was opened at 10 a. m. in the school house, by Judge Johnson. Quite a number of applications were presented and allowed, there being no contest filed, except one by W. C. Burrows, against the Union Park Coal company, which, however, was withdrawn.

During the morning session the following persons were admitted to citizenship: Thorburn Johnson and Ole Johnson, fathers of John and Thomas Jenkins of Water; James Wallace Reid, Andrew Wallace and James Davidson of Scotland.

When court was called to order at 5 p. m., Charles Swinger, a native of Germany, was admitted to citizenship. The ground upon which he was allowed was that he had resided in the United States for five years, and was a good man, of good character, and was a native of Germany.
