When Will the Rush for Divorce Come to an End?

A NUMBER OF NEW SUITS.

In the Third district court yesterday Estate M. Wilkinson brought suit against John C. Wilkinson for divorce. In her complaint the plaintiff alleges that she was married to the defendant in this city in June, 1877, and that the issue of the marriage is three children; that for several months prior to the defendant has been guilty of cruel and inhuman treatment towards the plaintiff; that he is an habitual drunkard, and that his conduct towards her is such that it is unsafe and improper for her to longer live with him. The plaintiff states further particular instances of cruelty, and alleges that, to the fall of 1880 he used her by the arms and threatened to cut her throat with a razor that he was brandishing that on August 21 last, while in a drunken condition, he wrenches her arms, beat her, and threatened to kill her. She also states that she has been compelled to give up her mining claim in the Ophir mining district and some property in Ophir, Nebraska; all of the value of these items she says for a decree of divorce for the safety of the children and her attorney.
