

Councilor Smoot introduced C. F. No. 1, "A joint resolution appointing a legislative commission." Read first and second times, discussed and lost.

The President appointed Councilors Wells and Smith the committee on the part of the Council called for in the joint session resolution, to memorialize Congress in relation to the University lands.

Councilor Smith moved to incorporate in the general appropriation bill \$300, to be disbursed to individuals who had traveled through the Territory in the interest of schools. Carried.

The House resolution offered by Mr. Fisher, requiring the Auditor of Public Accounts to have the amendments to the Compiled Laws printed on slips for distribution to those having copies of the Compiled Laws, was amended and concurred in.

H. F. No. 92, "Making appropriations for general purposes," was taken up, and, after much discussion and numerous amendments, passed.

A message was received announcing the Governor's approval of C. F. No. 1, "Guardian and Ward."

C. F. No. 44, "Amending section 1173 Compiled Laws" (Townsite Act).

C. F. No. 29, "To punish persons entering into or upon railroad cars in certain cases." And

C. F. No. 12, "To legalize the execution and acknowledgment of certain deeds."

The House concurrent resolution concerning distribution of the journals, etc., was concurred in.

The vote rejecting the House amendments to C. F. No. 16, "To incorporate Park City," was reconsidered and said amendment was concurred in, which passed the bill.

The committee on claims and appropriations reported adversely upon the petition of the Mayor and City Council of Salt Lake City for aid in constructing the Salt Lake City and Jordan Canal, and the report was adopted.

The appropriation bill was received from the House with some of the Council amendments not concurred in. The Council receded from some of its amendments and declined to recede from others, and the bill was returned.

After several messages to and fro, in regard to differences in regard to the appropriation bill, a committee of conference was called for, and the President appointed Councilors Wells, E. Snow and Smoot said committee on the part of the Council.

The committee of conference agreed upon certain amendments in regard to jury and witness fees and appointing a commission to see that the same were properly extended, which were concurred in and said commissioners were appointed, and the bill passed.

A resolution was adopted, thanking the President and officers of the Council for the gentlemanly and efficient manner in which they had performed their duties.

A message was received from the Governor, announcing his approval of C. F. No. 41, "Amending the charters of incorporated cities, etc.," C. F. No. 18, "Amending the charter of Salt Lake City," C. F. No. 43, "Providing for the election of the clerks of the County Courts," and C. F. No. 30, "To establish a Territorial Insane Asylum, etc."

Councilors Caine and Cluff were appointed a committee to act with a committee of the House to wait upon His Excellency the Governor, to inform him that the tables were clear of business and to inquire if he had any further communication to make to the assembly.

Joint resolutions of respect were adopted to His Excellency the Governor and Hon. A. L. Thomas, Secretary of the Territory.

Councilor Caine, chairman of the committee appointed to wait upon His Excellency the Governor, reported that he had no further communication to make. Council adjourned sine die. Benediction.

HOUSE.

Thursday, February 19th, 2 p. m.

On motion of Mr. Sharp, the further reading of Council amendments to H. F. No. 27, "Pertaining to highways," was postponed.

Mr. Carrington, chairman of municipal corporations, etc., presented the following report:

Your committee on municipal corporations, etc., to whom was referred C. F. No. 18, herewith return said bill with amendments, and recommend its passage as amended. Amendments to C. F. No. 18,

"Amending the charter of Salt Lake City," were read and adopted, and the bill passed.

Mr. Grover chairman of irrigation, presented the following report:

Your committee on irrigation, etc., herewith return C. F. No. 39, and recommend its passage.

H. F. No. 27, "Pertaining to highways," Council amendments read and adopted, except the amendment to section 21.

Mr. Grover moved that a conference committee be appointed on said amendment.

The Speaker appointed Messrs. Grover, Lyman and Preston said committee.

Your committee on municipal corporations, etc., to whom was referred a petition from Oliver Thornton and 58 others, for changing the eastern boundary of American Fork City, herewith return said petition, with an accompanying bill as prayed for, and recommend its passage.

H. F. No. 88, "To amend the act to incorporate American Fork City," passed.

C. F. No. 39, "To provide for right of way for canals for Salt Lake City," passed.

The following message from the Clerk of the Council:

I am directed to inform your Hon. Body that the Council has concurred in House amendments to C. F. No. 18, "Amending Salt Lake charter," except in such cases as are marked, and in those cases has offered amendments to said amendments.

Council amendments read. One adopted and two rejected.

Mr. Murdock presented petition of J. J. Cooper and 50 others, asking to change the county seat of Piute County, and moved its reference, without reading, to the committee on counties. Referred.

The following message from the Council was received and read:

The Council asks a conference to consider House amendments to C. F. No. 35, "Criminal cases," and has appointed Messrs. Caine and Smith said committee on part of Council.

The Speaker appointed Messrs. Farr, Smith and Dusenberry, conference committee.

The following message from the Council was received and read:

The Council does not recede from its amendments to C. F. No. 18, "Amending charter of Salt Lake City," and ask a committee of conference. Councilors Smith and Caine appointed said committee on part of the Council.

The Speaker appointed Messrs. Farr, Carrington and Penrose, conference committee.

On motion of Mr. Carrington, Mr. Sharp was added.

House adjourned until Friday, at 10.30 o'clock a. m.

Mr. Johnson, of the Conference committee on the education bill reported that the committee had adopted Mr. Jacques, amendment with the following change: providing that the rate of tuition shall not exceed \$3 per term instead of \$1 per term. Report received and adopted.

A message from the Council was received with accompanying message from the Governor announcing the passage of C. F. No. 27. Message read.

Mr. Carrington, chairman of municipal corporations reported back H. F. No. 89, "To punish hotel runners, etc.," with amendments.

Mr. Preston, chairman of enrollment reported that the following bills had been enrolled and sent to the Governor:

H. F. No. 77, "Apportioning the legislative representation."

H. F. No. 81, "Changing boundary of Sanpete, Wasatch and Utah Counties."

H. F. No. 1, "Removing political disabilities of women."

Mr. Fisher, chairman of special committee, reported the destruction of cancelled auditor's warrants.

Mr. Preston, chairman of mineral resources, reported adversely on C. F. No. 26, "To protect coal miners," and presented H. F. No. 89, "To protect persons and animals in certain cases," which was read first and second times and referred to the committee on revision.

Mr. Lyman, chairman of claims, presented H. F. No. 90, "To prevent husbands mortgaging their homesteads without consent of the wife," which was adopted as substitute for H. F. No. 83, rejected, and was read first, second and third times and passed.

Mr. McKinnon moved that the committee on claims be instructed to consider the propriety of appropriating \$1,500 to build roads in Rich

County. Referred to committee on claims, etc.

Mr. Murdock reported that the following officers were to be elected at this session; 1 chancellor, 12 regents, 1 treasurer, 1 Territorial surveyor general, 1 librarian, 1 recorder marks and brands, 1 Territorial road commissioner, 1 warden of penitentiary, 1 sealer of weights and measures.

Mr. Fisher moved, the council concurring, that a joint session be held at 7 p. m., for the election of officers, carried.

House took recess until 2 p. m.

2 p. m.

Petitions of Snider and 130 others asking for the incorporation of Park City were read.

C. F. No. 16, "To incorporate Park City," was read and passed.

C. F. 43, was read and referred to claims, etc.

Council amendments to H. F. 65, adopted.

The Council sent request that the joint session be held at 8 instead of 7 p. m. Adopted.

Mr. Preston moved that an appropriation be made to pay deficiency of salary to officers of the Legislature, to be reimbursed on receipt of Congressional appropriations for that purpose. Referred to claims, etc.

Mr. Peery reported back H. F. 44, prohibiting marriages in certain cases. Report adopted.

Mr. Lyman presented H. F. No. 91, "To protect cattle growers and to preserve the pasturage of the public lands in the Territory." Referred to committee on agriculture.

A message from the Council was received asking for conference committee on C. F. No. 16, to incorporate Park City.

The Speaker appointed Messrs. Pack, Carrington and Dusenberry.

H. F. No. 17, "To amend the charter of Ogden City," was taken up, amendments read and adopted and the bill so passed.

Mr. Farr, chairman of judiciary, reported back H. F. Nos. 83 and 87, with amendments which were read and both bills passed.

Council amendments to H. F. 84 adopted.

Council amendments to H. F. 59, "Creating jury funds, etc.," adopted.

Mr. Pack of conference committee on C. F. 16, "Park City," reported that the committee had adopted House amendments.

Mr. Sharp, chairman of revision, reported back H. F. No. 89, "To protect persons and animals in certain cases." Read as amended and passed.

Mr. Lyman, chairman of claims, reported H. F. 92, "General appropriation bill," which was read and recommitted.

C. F. No. 45, passed by Council, was laid on the table to come up in its order.

Mr. Grover, chairman of irrigation, presented H. F. No. 93, "The water bill," which was read its first, second and third times, and passed.

A message from Council was received announcing that the report of the conference committee on C. F. No. 16, "Park City," was not adopted.

H. F. No. 44, "Amending section 1173 of Compiled Laws," was read first, second and third times and passed.

C. F. No. 45, "To provide for election of clerks of county courts," was read first, second and third times and passed.

House took recess until 7 p. m.

7 p. m.

The House after receiving and reading several Council messages, went into joint session.

On resuming its sitting, Mr. Murdock reported inability of the committee on printing to agree with the Public Printer, on the bill presented for printing done.

On motion of Mr. Carrington the bill of the Public Printer was allowed as presented.

C. F. 30, "insane bill" was read the third time by its title and passed.

Council amendment to H. F. 70, was read and adopted.

Council amendments to H. F. 71, adopted.

Council amendments to H. F. 81, adopted.

Mr. Smith reported back H. F. 91, without amendment.

H. F. 91, "to protect cattle growers and preserve the pasturage of public lands of this Territory," was read the second time by sections, and,

On motion of Mr. Grover, the enacting clause was stricken out. Council amendment to H. F. 17, adopted. Mr. Lyman, chairman of claims, etc., reported adversely on the following claims and petitions:

N. D. Rosenbaum, assessor and collector of Box Elder county; A. M. Musser for \$1,500 to assist Madsen & Sons to make sugar; of F. Kingston; of Stearns Hatch; "The deficiency bill;" M. D. Hammond, to aid in holding county fair; Utah county D. A. & M. Society, for same purpose; Smith and Ford; J. H. Henderson, county treasurer of Iron county; O. H. Riggs; of W. J. Cox, and of Mrs. M. Miller. Report read and adopted.

Mr. Hatch reported certain bills and petitions in his hands, left over from the last session, and asked that they be returned to the clerk's desk. So returned with instructions to file them in the auditor's office.

H. F. No. 92, "Appropriation bill," was read the second time by sections.

Council amendment to H. F. 83 read and adopted.

Mr. Lyman, chairman of committee on Claims, etc., reported favorably on the following claims and petitions:

S. S. Smith, for Escalante road, \$3,000; Juab County relief; H. H. Cluff; Herold P. & P. Co.; G. Belknap; Rockwood estate; A. McKinnon; A. E. Mirriam; Dr. S. B. Young; Wm. Reeves; W. D. Johnson; grand and petit jurors, and \$10,000 to Deseret University for grounds and building annually for two years. The committee reported adversely on C. F. No. 43, "For bureau of statistics."

A message from the Governor announcing his approval of the following acts was read:

H. F. No. 27, "Highways."

H. F. No. 71, "Defining judicial districts."

H. F. No. 84, "For fencing lots, etc."

H. F. No. 81, "County and probate clerks."

H. F. No. 80, "Changing boundaries of Sanpete, Wasatch and Utah Counties."

The Speaker appointed Messrs. Penrose, Johnson and Fisher committee on the part of the House to memorialize Congress in relation to the allotment and distribution of school lands, etc.

Mr. Fisher presented a resolution authorizing the Territorial Auditor to furnish each member and officer of the Assembly one copy of the journals when compiled. Adopted.

The general appropriation bill, with amendments, was returned from the Council; amendments read and referred to the committee on claims, etc.

Mr. Penrose moved that when the Governor approves the school bill that it be published as an appendix to the report of the Supt. of Dist. Schools. Carried.

Mr. Lyman reported back the appropriation bill. Council amendments read singly and recommendations of the committee adopting some and rejecting others adopted.

Mr. Penrose presented petition of the Mayor of Salt Lake City, asking for \$25,000 to aid in the construction of the Salt Lake and Jordan Canal, and moved that it be granted. Lost.

Mr. Lyman, chairman of claims, reported adversely to Mr. Hatch's motion for \$1,000 to make a road from Heber City to Uintah Co., also on H. F. No. 75, "To appropriate money to the Deseret University," the provisions of said bill being provided for in the general appropriation bill. Report adopted.

A conference committee was appointed, consisting Councilors Wells, Snow and Smoot, of the Council, and of Messrs. Lyman, Smith, Preston and Murdock of the House to further consider the appropriation bill.

Mr. Lyman, chairman of conference committee on the appropriation bill, reported an amendment, which was unanimously adopted.

A message from the Council was received, announcing their adoption of the conference committee's report.

Resolutions of respect to the Governor, Secretary, Speaker, Chief Clerk of the House were presented and adopted.

Governor's message was received approving:

H. F. 89, To protect persons and animals.

H. F. 47, School bill.

H. F. 87, Amending sec. 191 Compiled laws.

H. F. 17, Amending charter of Ogden City.

H. F. 70, Amending the Game Law.

H. F. 93, The water bill.

The Council announced the appointment of a committee to wait on His Excellency the Governor, to inquire if he had any further communication to make.

The Council reported a message from the Governor approving C. F.

Nos. 41, 18, 45 and 30 which was read.

Messages from the Council with accompanying joint resolutions of respect to the Governor and Secretary were received and read. Resolutions adopted.

Mr. Lyman reported having waited on his Excellency the Governor, who stated that he would communicate with the House again.

Mr. Snow moved that the pay roll signed in duplicate by the members and officers for the additional pay which Congress has been petitioned to allow, be placed in the hands of the Territorial Auditor until the amounts signed for shall be paid by the Secretary. Carried.

A communication from the Governor announced his approval of the bill apportioning the Territorial legislative representation; the bill amending the revenue law, and the general appropriation bill.

Messrs. Lyman and Preston reported that the Governor had nothing further to communicate.

A message was received from the Council, announcing its adjournment.

On motion of Mr. Sharp, House adjourned sine die.

JOINT SESSION.

Friday, February 20, 1880, 8 p. m.

Pursuant to previous agreement, the Assembly met in joint session, The President of the Council presiding.

The Chief Clerk of the Council read the following report:

Mr. Penrose offered the following resolution:

I move the adoption of the following resolution:

Resolved, That a committee of both houses be appointed to draft a memorial to Congress asking for legislation, providing for the allotment and distribution, for school purposes, of sections 16 and 36 in each township within the limits of this Territory; also to make application to the Secretary of the Interior requesting him to issue the needful rules and regulations to make available for educational purposes, the University lands in this Territory, selected in accordance with laws of Congress. And that should said committee be unable to report before the close of this session of the Legislative Assembly, said memorial and application, when signed by the President and Chief Clerk of the Council and the Speaker and Chief Clerk of the House, shall be held to express with full authority, the desires of the whole assembly in relation to these subjects.
