WASHINGTON.  
Five minutes called in.

WASHINGTON, Sept. 1.—The Treasury department today issued a notice, calling for redemption, on or after the 1st of December next, one hundred millions of five-twenty-fives of 1862. The following is a description of the bonds so called: Coupon bonds known as the first series, of the act of February 25th, 1862, 1 to 2,306 inclusive, \$10,000 each; May 1st, 1862, numbered 1 to 30,699 inclusive, \$50 each; 1 to 41,572 inclusive, \$1,000 each; 1 to 40,011 inclusive, \$500 each; 1 to 74,104 inclusive, \$1,000 each. Registered bonds of the same act, 1 to 395 inclusive, \$50 each; 1 to 4103 inclusive, \$100 each; 1 to 1,800 inclusive, \$500 each; 1 to 8,000 inclusive, \$1,000 each; 1 to 2,905 inclusive, \$5,000 each.

Change of Agency.  
It is officially announced that Clewes, Hahle & Co., London, have been appointed official agents for the U. S. government for all foreign countries, which agency has heretofore been held by Earing & Co., for thirty years past, having been given them after the negotiation of the Ashburton treaty out of compliment to Lord Ashburton, who was then a member of the firm. The change is now made to recognize the services of Henry Clewes & Co., in behalf of the government in its financial measures in part, and to reward its own citizens by preference over foreign competitors when its own interest will be equally well served.

NEW YORK.  
The charges against the Health Officer, Albany, N. Y.—Governor Hoffman today replied to the complaints of Chas. H. Marshall & Co., of exorbitant charges and malfeasance in office by the health officer of the port of New York, Dr. Carnochan, in relation to the case of the ship W. F. Stever, which arrived at New York in April, 1871, with many cases of the typhoid fever and cholera on board. Governor Hoffman presents Dr. Carnochan's explanation of his charges for fumigation, vaccination and medical treatment as only just and reasonable, and refers the whole matter to the quarantine commission for further examination.

Further accounts of the expenditure sent to the board of supervisors by the city comptroller, appeared in the Times today, from which it is shown that the warrants issued to the New York Printing Co., for printing for the year 1869, 70 and 71, amount to \$1,401,399. NEW JERSEY.  
Patterson, N. J.—Walter Conkling, a friend of Alice Bowley, the victim of this afternoon by shooting himself in the neck, dying in a few minutes. He was the son of Alderman Conkling. The cause is supposed to be his presumed complicity in the Bowley affair. Orders were given at the police headquarters in New York, this morning, to have Conkling arrested.

SOUTH CAROLINA.  
Yellow Fever.  
CHARLESTON, S. C.—There are no new cases of fever. Two of the persons attacked last week died today.

FOREIGN NEWS.  
PRUSSIA.  
Berlin, Prussia.—A dispatch from Gumbinnen, a town of East Prussia, says that in the small village of Chimacow, with a total population of 479, there have already been 79 cases of cholera, 46 of which have terminated fatally.

WEST INDIES.  
A terribly destructive hurricane and gale.

ST. THOMAS, 22, via Halifax, 31.—Another hurricane has swept over this unfortunate island, overturning every house and laying the place in ruins. Yesterday a gale broke from the east, shortly afterwards shifting to the north-east, from which point it blew more fiercely until noon, when the wind veered round to the north and fell upon the island in a terrific hurricane. It then shifted to the north-west, and blew with great violence until five p.m., when there came a lull, which lasted until 6 p.m. At this hour the hurricane again swept over the island from the south, but its duration was not so long as on its previous visit; nor was its violence so great. Its term of greatest fury lasted only two hours. Closely following in the wake of the hurricane came an awful gale from the south and south-east, which raged for several hours. During the hurricane in the afternoon, several shocks of earthquake were felt, more shocks of the situation of the people, who were hearing overhead the crash of roofs torn by the hurricane, and obliged to feel, at the same time, under foot the foundations of their dwellings being shaken by the earthquake. Hundreds of dwellings have been swept away, and not a house is left standing undamaged on the island. Some six thousand people are left homeless and destitute, nearly a hundred and fifty persons are killed and mangled, or disabled by the houses blown down, or by flying bricks and tiles. Already some thirty corpses have been dragged from the ruins. No reason can be given for the disaster. The island of St. Kitts is said to be in ruins, as it was caught first by the hurricane.

Versailles, 31.—In the Assembly today Picaid made a fervent appeal for harmony in the Chamber. The remainder of the preamble, in relation to the constituent powers of the Assembly, was adopted; and subsequently Du faure's paragraph, eulogizing the conduct of Thiers, was carried by a vote of 523 yeas against 34 nays. One hundred members abstained from voting.
