But that is a small matter compared with others that are brought to the front. Yet we draw attention to the fact that "Liberalism" has once more demonstrated that it is an assault upon a religion, aye more, it is an attack upon Religion, for all religious are founded upon the ideathat 'revelations have come from without," that is from the Supreme Being to mortais. If the Methodist creed is not built upon that foundation, then its whole history is a living lie.

Christianity, in whatever form it appears today, was originally started on the doctrine of "revelation from without." The doctrine was not one of mere internal impressions evolved from the mind of man, but of visita. tions from divine and angelic beings, and inspirations that come from the Holy Ghost sent down from heaven.

So with all the great religious of the world. Manifestations and communications from the higher spheres to the lower, not spontaneous human imaginings and conceits were the sources from which they emanated.

The lessons of history teach the very reverse of the "Liberal" resolution. The Bible and all the sacred books of the ages and the nations are against it.
