Ferry's Resolution Passes in the City Council After a Hard Fight.

MARTIN MULVEY IS ASHAMED.

#### Shocked and Pained at the Statements Made by Some of the Speakers -Petitions Ignored.

After one of the warmest fights which has occurred for months in the councichamber, the city council last night adopted the Ferry resolution, which appeals to the state legislature to aid the "American" party administration by authorizing the council to levy a tax of not more than three mills to pay the interest on the bonded indebtedness and to provide a sinking fund for the redemption of the city's bonds. It is figured by the administration that with the interest cared for in another fund the interest cared for in another fund it will allow the use of the entire con-lingent fund for contingent purposes which is greatly needed to meet the extravagance shown by the administra-tion during the past year. The vote on the resolution was eight to six, with one member absent when the vote was tak-en. Those who voted for the resolution were Black, Carter, Crabtree, Ferry, Hobday, Mulvey, O'Donneil and Davis, and those who voted against were Barnes, Fenstrom, Holley, Preece, Tuddenham and Wells, Martin was absent at roll call.

CHARGES EXTRAVAGANCE.

When the resolution was read Ferry explained the purpose of it and urged that it be adopted. Wells then secured the floor and submitted figures which showed that he had carefully studied the auditor's report. He pointed out where he though that extravagance was there much in ordenees and supwhere he thought that exit vagance was very much in evidence and sug-gested that the finance committee make some investigations toward a more economical administration in such departments. Continuing he said in sub tance

stance: "I have been looking over the audit-or's report and have made some deduc-tions which I think might prove of in-terest. Even if the resolution went through in its present form it would not provide money for the improve-ments along the lines we have started out to provide, and with due economy I think we can pay the interest on the bonds without burdening the people with additional taxes.

"The additor's report shows, among other things, a decrease in the receipts for fines and forfeitures of \$26,000 over the previous year, although 1 under-stand that gambling and the kindred evils still continue pretty much as they always did. I do not know whether these fines and forfeitures have been imposed or not, but the report does not show the receipts of anything like as much money from this source as for-merty. Under the previous administra-tion arrangements were always made whereby the balance on hand was put out at interest at from 21% to 3 per cent. The report shows \$626,000 on band Jan. Carter suggested that Fernstrom be allowed to prove the assortions made by him in regard to the police depart-ment and Fernstrom replied that he would be glad to do so at any time they wanted to start an investigation. Black at this point made a strenuous plea for the adoption of the resolution. He endeavored to show that the city's finances were all right and that econ-omy had been priorised in all the de-partments but still the administration needed the money which the three-mill levy would give it. Crabuse then got back to the gam-biling deal again, declaring that there is no gambling going on in the city at

no gambling going on in the city at this time, and that the present admin-istration did not have to depend upon the fines against gamblers for its reve-Wells again took the floor and reiter-

Wells again took the floor and reiter-ated his previous remarks. He denied that he had ever favored open gam-bling and cited several instances where he had endeavored during the previous administration to put a stop to it but had failed. He believed, however, that the old condition of gambling under restriction was preferable to the present police scandal, and still maintained that gambling is going on all the time in the city. the city.

MULVEY WAS PAINED.

Muivey, in a very cool way, upbraid-ed his colleagues for the talk they had made during the discussion of the mat-ter. He said that he was sorry that they had resorted to such statements

ter. He said that he was sorry that they had resorted to such statements as had been made and that he had never heard such things on the floor of the council during all the time he had been in the council during the past as well as the present term. He said that gambling and other vices always exist in large eitles and that it is a mistake to say that it is not going on here. No matter what the police surroundings are, he said, you will always have gambling, the only question is how itt-tie. He expressed regret that the mat-ter came up and hoped that it nevas would again on the floor of the council as long as he was a member. Ferry made the closing argument on the resolution and said that he regret-ted very much that a spirit of partisan-ship should be shown in this matter as he considered it a move for the benefit of Sait Lake City and the spirit shown boded ill for the fate of the resolution as far as the legislature is concerned. The roll was then called and the reso-lution was adopted by the vote given above. The matter will now be brought to the attention of the legislature and it will be a matter for its members to determine whether or not the addition-al three mills tax levy will be author-ized.
