The Becker Brewing company's safe was blown open yesterday by probable cracks. It is not known what amount of cash was secured. Mr. Becker is in town having a previously started in Mercer, Ohio. Davenport and Detective Fander did some good work, for within two hours after being informed of the theft they had three men arrested. Frank Kell, Dan O'Neil, and John Williams. Williams, a colored man, the police got track of them and found them sleeping in the Little Room lodging house. After a careful search the officers found two men in the room, a gold watch enclosed in paper, part of the safe robbing, the metal having been presented by the Ogden gun club to Mr. Becker. The arrested are the same three arrested at Provo for blowing open the U. P. safe at that place.
