HOME ITEMS.

DISTRICT COURT .- On Tuesday, 14th, the Court met pursuant to adjournment, when the record of Monday was read and signed by the Judge.

The case of Wm. A. Carter vs. E. M. Morgan, as principal, and Holladay & Halsey, as garnishees, was called. Thomas A. Janney and Patrick Lynch testified in the case, when it was submitted to the Court, and judgment was rendered for the amount claimed, viz: \$2,375,45.

In the case of J. P. Tiernan vs. the people, &c. E. W. East, Clerk of the Probate Court of this county, stated that his reason for refusing to certify up the records of the proceedings had in the case in the Courts below, was that the costs had not been paid by the appellant. The Court being advised that the appeal bond had been filed, stated that such was security for both judgment and costs, and therefore ordered said record to be sent up, and also a certified transcript of the record in the case of the people vs. Frank F. Fox.

Leonard I. Smith vs. James Wilburn and Daniel Armitage, in attachment, was called, and withdrawn by the plaintiff's counsel, a settlement having been effected.

In the case of the people vs. Joseph Holladay, on indictment for manslaughter, Mr. Miner asked the Court to set some time for the trial that would allow the defendant and senior counsel in the case an opportunity to arrive here; the Court ordered peremptorilly that the trial be set for the first Monday in May.

Wednesday, 15th.

Court met pursuant to adjournment. The first case called was that of James E. Walker vs. Nevitt & MacDonald, alleged to be partners. Mr. Miner, counsel for defence, filed a plea in abatement, denying the partnership of the parties complained of. Mr. Appleby gave notice that he would file a replication to-morrow.

The case of Feramorz Little vs. Wm. B. Twitchell, in ejectment, on appeal from the Probate Court, was called, when the following jurors were duly empannelled to try it:
