## BLUNDER SAVES ALLEGED ROBBERS

Blamlett, McGuire and Garrett Get Their Case Dismissed Through Error.

### MEN FRIGHTFULLY BURNED.

By Explosion of Barrel of Paint at Carlin. Two Railroad Employees Burned in Peculiar Manner.

H. L. Johnson and D. A. Meyers, employees of the Southern Pacific shop at Carlin, Nevada, were frightfully burned Monday afternoon by a large barrel of linseed oil paint. According to the report received at the superintendent's office in this city, the barrel had been rolled near a large heating stove in the shop to allow the paint to soften. The staves caught fire and before the men could be moved or the flames

extinguished, the barrel exploded and burning paint was hurled in every direction.

Johnson and Johnson were standing near the stove and both were literally covered with the burning paint. Employees rushed to the aid of the injured men and also checked the flames which were spreading in the building. Meyers was found to be terribly burned about the face, head, legs and hands. Johnson escaped with a number of painful burns about the face and hand, but not as bad as Meyers.

The company physician attended the men but it was deemed advisable to send Meyers to the Ogden general hospital, at which place he arrived last evening. It is stated he will recover from his injuries, but it is feared his sight may be affected.
