I turned the horse and had driven but a short distance when I saw a man coming from some bushes where he had been hiding and came up to me. He threw up his hands and told me he must be joking. He replied, 'You had better give up, and at the same time fired a shot at me, which did not hit me. I handed him my pocket book, from which he took the money in my wallet and threw the wallet back to me with the papers, saying, 'I don't want that rubbish.' At this juncture another shot was fired, the ball striking me in the breast, inflicting the wound I received. I did not see any other man, although there were three men at the house's head and neck, as I was so confused. My watch and chain and some other articles were also taken. All I know subsequent to the shooting was that I was taken by some men to the hospital."
