Plaintiff alleges that she purchased a piece of land from defendant in 1901 and has paid for it according to the agreement, and now defendant refuses to issue the deed, and she therefore asks that the court require him to do so. The land in question is located on Madison avenue near Twentieth street.

Sarah E. Wheeler et al. have brought suit against Fred L. Fox and William Wheeler to secure an injunction to prevent defendants from fencing up a roadway at Slaterville, over which plaintiff claims a right of way.
