

## DIVORCE MILL TURNS OUT FIVE

Quintet of Abused Wives Tell  
Their Troubles to Judge  
Armstrong.

GIVES THEM ALL DECREES.

Desertion, Cruelty and Failure to Support  
Are the Reasons Responsible  
For These Ruined Lives.

Judge Armstrong conducted the regular weekly divorce matinee yesterday afternoon on account of the absence of Judge Morse. Five women were freed from the matrimonial bonds and went on their way rejoicing and probably to find other husbands.

**FAILED TO SUPPORT HER.**  
Sadie M. Russell told the court of the failure of her husband, John Russell, to support her and her two children. She said that he had given her only \$5 during the past three months and that she was compelled to eke out the family for assistance. She is now living with her mother. She was awarded a divorce, the custody of the children, \$25 per month alimony and \$50 as attorney's fees.

**PARSONS WAS CRUEL.**  
Cruelty is the ground on which Sarah A. Parsons was granted a divorce from R. A. Parsons. The plaintiff told the court that her husband frequently abused her in the presence of their six children and had threatened to kill the whole family. She was corroborated by her 15-year-old daughter, who declared that her father never had treated her mother right since she was old enough to remember.

**ANOTHER MAN FAILS.**  
Genevieve K. Epps informed the court that her husband, Frank L. Epps, had failed to support her for several months past although he has been earning \$200 per month as a mining man. She declared that her husband frequently abused her by taking in taking in. She was granted a divorce.

**FOUGHT HER OWN BATTLE.**  
Nellie Battle was divorced from Robert L. Battle on the ground of non-support. They were married on April 18, 1896, and have a daughter eight years of age and for the past two years Mrs. Battle has been compelled to support herself by clerking in one of the big stores of the city.

**CHARGE OF DESERTION.**  
Desertion and non-support are the charges made by Florence Lieberthal against H. N. Lieberthal, whom she married on March 24, 1906. She was granted a divorce and allowed to resume her maiden name, Florence Schaefer.

**CRUELTY AND NON-SUPPORT.**  
Cruelty and non-support are the grounds upon which Florence Frenzel asks a divorce from Orlando Frenzel, whom she married on Nov. 2, 1906. She alleges in her complaint that her husband has never supported her since their marriage and that he has treated her in a cruel manner thereby causing her great mental anguish. In addition to a divorce she asks for alimony and attorney's fees.

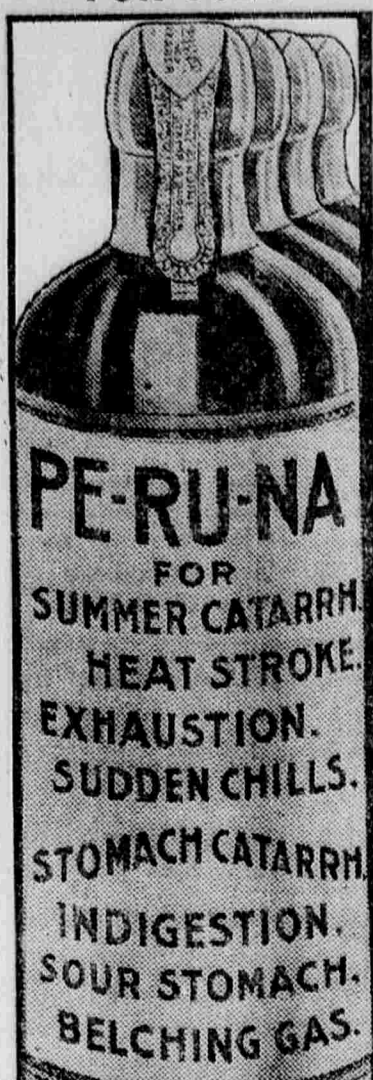

## RELAYING MAINS WILL BE COSTLY

Engineer Kelsey Submits Estimate for Doing Work Over on  
First and Second Av's.

NO DEFINITE ACTION TAKEN.

Pure Food Law and Bicycle Ordinance  
Also Considered by Council  
Last Night.

City Engineer Kelsey last night submitted to the waterworks committee of the city council an estimate of the cost of relaying the watermains on First and Second avenues, which are now being macadamized. Owing to the heavy cost of the work it was not intended by the council to enlarge the mains on those streets this year, but in excavating for the four blocks on First avenue that are being macadamized will be \$2,611.25; on Second avenue from Canyon road to C street the cost will be \$3,804.44; from J to O street on Second avenue the cost will be \$3,968.49, making the total cost \$10,384.18. There was quite a disagreement among the members of the committee as to the city being financially able to do even the part of the work mentioned this year, and, although Tuddenham and others insisted that it is an absolute necessity, no definite action was taken on the matter last night.

The new pure food law and the new bicycle ordinance were both discussed by the municipal laws committee last night, but no final action was taken as to either.

## LIQUOR PACKAGES.

Order Revoked Compelling Express  
Co's. to Carry Them C. O. D.

Kansas City, Mo., July 5.—Judge John C. Pollock in the United States district court here today revoked his mandatory order compelling express companies to carry C. O. D. liquor packages and denied a temporary injunction against the Wells-Fargo Express company and the Pacific Express company, asked by the Harvest King Distilling company, forcing the express companies to accept its shipments.

Judge Pollock held that there is no common law duty resting upon the express companies to engage in a C. O. D. liquor business.

May 15 several express companies
