

TWO BOGUS COUNCILMEN

Recently Ousted by the Supreme Court Obtain Other City Offices.

ARMSTRONG IS NOW A POLICEMAN.

Noble Elected a Member of the Board of Public Works—Quarterly Reports—Miscellaneous Business.

An adjourned session of the City Council was held last night, Mayor Noble presiding. The members present were: Noble, Kierulff, Heath, Pendleton, Falkland, Hyde, Hardy, Tullerham, Young, Anderson and Ayers.

The following petitions were read and referred as mentioned below:

J. V. Smith asked for cancellation of special sprinkling tax. Committee on sprinkling.

J. E. Price asked for permission to file building material in front of 375 south Second East Street for three months. Referred to the mayor.

William Shurtliff asked to be appointed to a position on the police force. Referred to the mayor.

Benjamin B. Young asked for a corrected deed. Referred to the city attorney.

The same gentleman asked that the collection of a sprinkling tax on certain property be temporarily deferred. Committee on sprinkling.

A. G. Peltier asked that \$54.80 be paid from Dulles & Williams, contractors on the Park's canyon conduit, to the Board of Public Works.

John Sullivan asked permission to transfer the unexpired portion of his mayor's term to J. N. Norton. Committee on houses.

Joseph C. Baker, administrator, asked for remission of special sidewalk tax. Board of public works.

The hall of the dramatic association and many other persons owning property on Ninth street, above First street, protested against the proposed grade for that street being established. Committee on streets.

G. W. Boyd and others asked that the grade on Second South street, between Fourth and Fifth West, be lowered a foot. Committee on streets.

The Puppert Place and Fort Jackson Rapid Transit company asked for a franchise for a single or double line street railway on Fourth street from the military reservation to Sixth street and thence south to Brigham.

Along Second South street from Superior Place to T street, the same south along T street to First street. Committee on streets.

John Mac at asked that a wagon and foot bridge be erected over the canal on Ninth South street, between Ninth and Eighth West streets. Committee on streets.

Frank Alvord asked for a position on the police force. Referred to the mayor.

E. F. Cunningham also asked for appointment to a position on the police force. Referred to the mayor.

The communication of twenty-five members of the police force complaining of their treatment by Captain Palmer and Sergeant Glenn, was read and referred to the committee on police.

Henry Anderson asked that a certain amount of money be loaned from Holmes & Wilcox, be withheld. Board of public works.

F. D. Child asked to be allowed to make private contract for the purchase of a certain sidewalk in front of his residence. Board of public works.

Spencer Clawson asked to purchase a piece of property known as a continuation of Ninth street. Committee on public grounds.

A BOGUS COUNCILMAN'S RESIGNATION.

Mayor Noble reported that he had accepted S. P. Armstrong, one of the ousted bogus councilmen, to a position on the police force in place of D. Alderton, resigned. Confirmed.

RETIRED MAN'S RESIGNATION.

M. H. Howie tendered his resignation as a member of the Board of Public Works. The resignation was accepted.

Councilman Anderson moved that W. P. Noble, the long serving city engineer, who was recently ousted by the supreme court, be appointed to succeed Mr. Howie.

Councilman Young placed in nomination the name of ex-Mayor Armstrong. The vote was Armstrong 5, Noble 4. The latter was declared elected.

CITY ENGINEER'S RESUME.

City Engineer Norman reported that he had examined and arranged for right of way through certain lots owned by Joseph Dudley, for Park's canyon conduit, at a cost of \$100 and asked that an appropriation of the amount mentioned be made. Adopted.

The same officer reported that the work of putting sidewalks was now under way but that no provision had yet been made for paying the laborers and street cleaners and asked that action be taken on the matter forthwith. Committee on streets.

The report of the city engineer for the quarter ending June 30, 1891, showed the expenditures of the three months to be as follows: April, \$22,000; May, \$20,000; June, \$20,000; total, \$62,000. In addition there were miscellaneous expenditures amounting to \$10,000, making a total of \$72,000. The receipts for the quarter, \$14,114, net expenditures, \$57,886. Received and paid.

FROM THE CITY ATTORNEY.

City Attorney Hall, in whom was referred the application of the dramatic company, for permission to lay a block of sidewalk, asked that the granting of this privilege might imperil the levying of the tax and insurance of the city and therefore recommended that the application be refused. Adopted.

The same officer reported that he had notified the owner of the property on the Warm springs property, as directed. Adopted. Mr. Hall also reported that Mrs. C. H. Kierulff had made a proposition to settle her claim for damages for \$250. Committee on claims.

CONDUCT APPROPRIATION.

The board of public works reported that the amount of \$37,700 was paid Dulles & Williams for work on Park's canyon conduit, and that \$34,000 was paid to the same company for work on the Park's canyon conduit. Adopted.
