THE SALARY BILL.

WASHINGTON, 9.—At the expiration
of the morning hour the House
took up the bill to repeal the
increase of salary act. Cox favored
the measure, and that it may be
sent to the Senate.

Ingalls introduced a bill to arm
and equip the whole body of the
militia of the United States.

It was agreed that the
militia should be appropriated
annually for that purpose, and that all arms issued to the militia shall
be of the same pattern as those
adopted for the U. S. Army.

THE SALARY BILL.

WASHINGTON, 9.—At the expiration
of the morning hour the House
took up the bill to repeal the
increase of salary act. Cox favored
the measure, and that it may be
sent to the Senate.

Lawrence favored the repeal be-
cause it was demanded by the
people. He argued that the increase
would result in the defeat of the
Republican party. Some amusement
was created by the admission of
Mr. G. that he, in reply to a
question, said the bill had been
put over to the back pay under the law of 1862.

Kendall, of Nev., opposed the re-
peal. He respected public clamor,
and argued to show that the in-
crease was just in considering
the abolition of the franking
privilege, mileage, etc.

Nugley would favor the repeal of
the bill as it was presented as a
measure of economy, but did not
argue to show that there was
nothing worthy of dishonor in
passing the bill, and that it may
vote for it and still be
honorable in integrity and conscience
of the multitude of his detractors.

Wade, of Ind., voted to demand
repeal, and at that hour did not
hope that the law would be re-
pealed, and the salaries left as they
were before.

Taylor advocated the amend-
ment proposed by himself, fixing
the salaries of members at \$6,000.

Lynch argued that whatever
change was to be made, whether
an increase or a decrease, it should
not take effect during the present
Congress.

Hale, of Me., gave notice that he
would try to get a vote on the bill
to-morrow.

Forrest advocated the amend-
ment proposed by himself, fixing
the salaries of members at \$6,000.
