

SEC. 3. That in all cases of election by ballot, all tickets must be of paper, uniform in size, color, weight, of said Territory, and all of said texture and appearance; to be furnished by the Secretary of the Territory, and be paid for out of the territorial treasury; and it shall acts or parts of acts so far as the be unlawful for any person to put any number, figure or device upon said ballot, whereby any person may be enabled to ascertain by whom the ballot was given; and any violation of, or attempt to violate, this provision shall be deemed and taken to be a felony, and upon conviction thereof the person so of- The Season-Schools-Improvements. fending may be punished by a fine not exceeding five hundred dollars, or by imprisonment in the penitentiary not exceeding one year, or by both such fine and imprisonment, in the discretion of the court. And at all elections none but citizens of the United States over twenty-one years of age, and who have resided in the Territory four months next preceding, and in the county, precinct, or election district thirty days next prior to the election, shall be qualfied to vote.


