Washington, April 4.—The President has completed his Cuban message, and it will be presented to Congress on Wednesday, according to the official statement. The President's message will be in accordance with the action of Congress.

The message, which is in itself a long and carefully considered document, contains a full statement of the President's views on the Cuban question, and will be made public just as it is received.
