THE SMOKE NUISANCE, The deadly effects of the poisonous smelter smoke has manifested itself so plainly this season as to leave no doubt in the mind of any reasonable person that something should be done to take care of the same and thereby protect the interest of the whole country. In the last two weeks of damp weather the leaves on the trees have changed their color as though they had been singed by a flame. It is quite im-portant to note the vast extent of the district which is affected this season compared to the previous years. I past years it has only affected those in the locality of the smelters, but this year it extends as far north as Eleventh South and from there it extends over the whole of the county south. The smelters have been enlarging their capacity of late and every new roaster which is operated increases the volume of poisonous smoke. In some places of poisonous smoke. In some places the pears and apples hang on the trees bare and alone, while the leaves have been singed by the smoke until they have fallen off. The farmers of the whole county demand that something should be done to protect them from this nuisance. The smelters are wel-come, but with their prosperity they should look after the protection of the vegetation of the country contiguous to them.
