Section 2—Every person firm or corporation who shall operate and maintain in Sait Lake County, outside the limit of incorporated cities, any telephone instrument meationed in section 1 of this ordinance shall pay to Sait Lake County, for each telephone instrument for the use of which such person firm or corporation receives or charges a rental of sixty dollars per annum or over, a quarterly licunse of twenty-five (23) cents; and for each telephone instrument for the use of which such person, firm or corporation receives or charges less than sixty dollars per annum, a quarterly license of twelve and one-half (124) cents.

Section 2—Each person, firm or corporation maintaining and operating such telephone instrument or instruments is hereby required to furnish quarterly, to the county clerk, a complete list or said instruments. required to furnish quarterly, to the colling rierk, a complete list of said instruments, the list to give the location of instruments, and names of individuals renting the same the first of said lists to be filed not later than July 10, 1901; and the maximum charge for each instrument used shall not exceed the rates now charged for such or like
