DISTRICT COURT HEARINGS

L. J. Naphier sentenced to Penitentiary One Year for Sharp Practice.

Miss Phoebe Pearl Snyder Gave Recital in Detroit-Ogden City Schools.

L. J. Naphier was sentenced by Judge Rolapp to one year in the state prison. Naphier will be remembered by many as the man who was convicted of the murder of a woman named Mary. He was sentenced to the state prison for a term of one year. Naphier was a well-known figure in the community and his conviction was a surprise to many.
