

"My Dear Mr. Howard—May I ask you to cable directly to the governor of Jamaica an expression of the deep and sincere sympathy which the people of the United States feel for the people of Jamaica in their great misfortune? And whether the situation in Jamaica is such that the people are in need of supplies or assistance of any kind which we can send from our naval station at Guantanamo? If there is any. which we can send from our navel sta-tion at Gunntanamo? If there is any-thing that we can do to relieve or pre-vent distress, our mavy department will be most happy to do it, and Guantana-mo is so near to Kingston that per-haps early relief may be afforded from there. The message from London is interpreted here as meaning that the British government and people disayow the action of the governor of Jamaica in requesting Admiral Davis to disembark his men. The text of the dispatches referred to follows:

Meantime, Admiral Davis, who has arrived at Guantanamo from Kingston with the battleships Missouri and Indiana and the cruiser Yankton, is preparing a report which will be forwarded to Washington by mail. The subject was regarded as of such delicacy that it was deemed advisable to send it in this manner rather than by wireless telegraph. But it has already been anticipated here by the publication today of the correspondence between Admiral Davis and Gov. Swettenham. While the general sentiment here was one of extreme resentment at the freatment of Admiral Davis, there was no official who would venture to express himself in criticism for publication.

Acting Secy. of State Bacen was an early caller at the White House, where he was in conference with the president, and later it developed that the president took the position that there was nothing in the episode which would warrant the slightest representations by this government on the subject, and no representations will be made.

The promptness with which the government of Great Britain acknowledged its appreciation of the sending of the ships to Jamaica is indicated in the following correspondence which passed between Secy Root and Esme Howard.

INQUIR" TO BE INSTITUTED. Washington, Jan. 21.—Mr. Esme Howard, charge d'affaires at the British embassy, tonight called on Acting Secy. of State Bacon and presented a letter from Earl Grey, principal secretary of state for Great Britain, regarding the Davis-Swettenham incident. In his message Earl Grey says that he is causing an official inquiry to be made to determine the authenticity of the letter purporting to have been written by Gov. Swettenham to Rear Admirat Davis.

The British foreign office, said the charge, is entirely without official advices, their only information coming through press dispatches.

"If these advices prove to be correct," he said, "Great Britain will deeply regret that any British official should have written such a letter to the gallant admiral who had rendered such valuable assistance to British subjects at a time of great suffering and distress,"

Secy. Bacon assured Mr. Howard that President Roosevelt and the officials of the state department are much gratified to receive these messages from the British government, and especially so in view of the fact that they have been waiting official advices, concerning the unfortunate event before communication with the sector of the communication with the commun heen waiting official advices, concerning the unfortunate event before communi-cating with this government. No official advices have been received at the state or navy departments tonight, but the governmen officials have advised the British charge that they have no reason to doubt the authenticity of the press dispatches.

#### DEFEAT FORECASTED FOR SCHMITZ AND RUEF.

San Francisco, Jan. 21.-Although th supreme court today virtually forecasted defeat for Mayor Schmitz and Abraham Ruef in their application for a writ ham Ruef in their application for a writ of habeas corpus, the case was not decided, further hearing being arranged for tomorrow. The writs are sought for the purpose of removing the indictment case from the jurisdiction of Superior Judge Dunne. Francis J. Heney contested the application for a writ, claiming that the mayor had surrendered to the sheriff merely for the purpose of obtaining the writ and had never been actually imprisoned. A majority of the court seemed to take Heney's view of the case. After the noon recess, Chief Justice Beatty announced that the court was equally divided and he did not feel disposed to deprive the petitioners of a hearing.

Schmitz and Ruef made application for a writ of error to the United States supreme court, which was denied. The expressions of the justices today indicated that three were for issuing the writ as prayed for and three against it, with Chief Justice Beatty holding the deciding vote.

Two principal claims were set up by the petitioner. It was contended that no public offense or crime is stated in the indictment. The argument made in support of this contention was that the alleged extortion of \$1,000 from a French restaurant keeper for a license was not an atack upon his property rights, as a license is not "property" under the constitution. The second point made was that Grand Juror Wallace, being disqualified by reason of his lace, being disqualified by reason of his having served on a trial jury within one year, the entire grand jury was in-valid and the indictment returned against the mayor consequently in-

MAKE CONTRIBUTIONS.

CORPORATIONS MUSTN'T

Mr. Maun of Illinois opposed the bill on the ground that corporations should be permitted to contribute to election expenses if rich individuals were to do so, and he asserted that the effect of the bill would be to keep poor men out of office.

One of the provisions adopted by the house makes such corporation, upon conviction, punishable by a fine of not exceeding \$1,000 nor less than \$250, or by imprisonment for a set on fire. The fire was checked before the body was incinerated.
