

New York, Dec. 27 .- At the meeting of the section of social and economi science of the American Institute of Scientists, Charles A. Conant, vice president of the Morton Trust company, who presided, discussed 'Aspects of the Currency Question."

He said that although it was too much to expect Congress to pass at once a satisfactory measure for banking reform, yet in due time sound legislation must result. Otherwise, our prosperity will be arrested, our rapidly absorbed currency will prove inadequate and we must be put at a great disadvantage at home, and in competition with foreign nations. The proposed banknote reform, he declared, was not intended to aid the banks, but to relieve restrictions on credit."

Value of Livestock Handled in 1906 Largest on Record.

Chicago, Dec. 27 .- Figures on the business transacted at the Union stock yards for 1906 show the valuation of live stock handled to be the largest on record. The receipts for the year were slightly over 16,000,000 head, valued at slightly over 16,000,000 head, valued at \$314,000,000, an increase of \$20,000,000 over 1905. General prices fluctuated within a narrower gange than in pre-vious years. Beef cattle averaged 25 cents a hundred higher, hogs \$1 higher, sheep 20 cents higher, and lambs 5 cents higher. higher.



KILLED IN CHRISTMAS PANIC.







THE SANTA FE WILL ADOPT THE PENSION SYSTEM.

Topeka, Kan., Dec. 27.-Commencing Jan. 1, the Atchison, Topeka & Santa Fe Railway company will place in operation a system of service pensions of all lines of the system, from Chicago to the Gulf and the Pacific coast. to the Gulf and the Pacific coast. All employes of the company who have been in its service continuously for 15 years and have either reached the age of 65 years or have become permanently disabled will be entitled to a pension. The pensions will

be based on a percentage of salary or wages received. The minimum will be \$20 and the maximum \$75 per month. In exceptional cases the pension board may increase the allowance by not more than 25 per cent. Immorality on the part of an employe will be sufficient cause for the revocation of a pension. The pension board of the road will have complete charge of all pensions and their revocation. The first board appointed by President E. P. Ripley consists of J. W. Kendrick, George T. Nicholson, W. 

Secy. Shaw Issues Circular Regarding Their Acceptance.

Their Acceptance. Washington, Dec. 37.—Secy, Shaw has is-sued a circular in which he decides that hereafter no surety company shall be ac-cepted under the provision of the act of Congress approved Aug. 13, 1884, as sole surety on any stipulation or bond in which the United States is interested for any amount greater than 10 per cent of its paid up capital and surplus, un-less such company shall be secured as to any excess by reinstrance. Two or more companies may be accepted on any bond the penalty of which does not xeceed 10 per cent of their aggregate paid up capi-tal.
