SECOND DISTRICT COURT.

Cases Submitted and Heard by Judge Rolapp Yesterday.

Denies Shooting the Chinaman—Wm. Neely Adjudged Insane—That Smallpox Scare.

In the second district court, Judge Rolapp heard the following matters:

In the matter of the estate of Ambrose Greenwell, deceased, a petition was filed by Thomas Greenwell and seven others, praying that the court issue orders requiring Charles H. Greenwell, administrator, to give final accounting of said estate, and that the court make distribution of estate to the petitioners as the legal heirs of said estate. The court issued a citation, returnable Feb. 1, 1900.

A. J. Vander Vlies vs. Burnswick-Balk-Collander Co.; the arguments of both sides were heard and the jury instructed by the court; verdict returned in favor of the plaintiff.

In the matter of the estate of John Harriott, deceased, the court signed an order fixing Jan. 31, 1900, as the date of hearing on return of sale of personal property.

A. J. Anderson vs. Lars Hanson; suit to recover \$62, alleged to be due for rent; the testimony of several witnesses was taken, when court adjourned.

COMMITTED TO ASYLUM.

Wm. Neely was examined today by Dr. Baker and Forbes as to his sanity. They found him to be insane, and Judge Rolapp heard the testimony of several witnesses, when court adjourned.

DENIES SHOOTING THE CHINAMAN.

Yesterday, Frederick Knipferman, a boy about 14 years of age, was placed under arrest by the police on the charge of assault with a deadly weapon. The boy was brought before Judge Hall and pleaded not guilty, stating that he did not shoot at the Chinaman; he will have his hearing later. He was released on \$100 bonds, which were furnished. The Chinaman's arm seems to be getting along very nicely, and it is the opinion that the shooting was accidental.

SMALLPOX SCARE.

The smallpox scare in Ogden has proven a very minor affair so far, the only case so far having broken out is that of Miss Bohner, and the attending physician says she is recovering as rapidly as possible. Sanitary Inspector Myers informed our representative yesterday that the sanitary regulations through the city are being carried out in every particular, and that today's cases in a better and a more healthy condition than for some time past; that in the whole city there is not one case of diphtheria, and only one case of smallpox, and one case of scarlet fever. The vaccination of the school children is being conducted by a number of our physicians under the supervision of the board of education.

ENLARGEMENT OF SUGAR FACTORY.

Material and Machinery for Tripling Its Capacity—Contracts for 8,000 Acres of Beets. Special Correspondence.

Lehi, Utah, Jan. 20.—The Utah Sugar company elected their last beet for this season Saturday last at 1.30 p. m. and the last beets that went through the mill were just as good as when they were received in the sheds. The last strike of white granulated sugar was made this evening following, but they are continuing to work up a certain amount of raw sugar which will fully make three thousand bags. The balance of the low product will be taken over in the new wooden tanks that have been constructed on the outside of the factory until the commencement of next season. The reason for erecting these immense wooden tanks is that the eleven iron tanks of a capacity of 100 tons each where the low product heretofore has been stored, are to be taken out and replaced with

ST. GEORGE.

Heavy School Tax Voted—Death of Mrs. Pace—Obituary.

St. George, Washington Co., Jan. 17.—On Monday night the citizens of St. George met to consider and vote for a special school tax, for the carrying on of the work of the new school house. Joseph Orton was chosen chairman and P. L. Daguerre secretary of the meeting. Joseph Orton and the secretary, both being trustees gave some figures, as to the cost of the building as it now stood—the cellar and first floor \$19,500, the second story will cost \$5,500. FAIRVIEW, NEW MEXICO.

A New Settlement, with Plenty of Room for Industrious Farmers.

Fairview, New Mexico, Jan. 15.—Near Española station, on the Rio Grande railway, and on the east side of the Rio Grande is located the Fairview ward of the Church of Jesus Christ of Latter-day Saints. They are few in number, there being but nine or ten families, they belong to San Luis stake. They feel isolated and desire more strength to develop into a vigorous ward. The land is good and the climate excellent—neither too hot nor too hot. Flowing was being done in an orchard here today. The colony is not only weak but most of the people are poor. A few men with moderate means could find an excellent opening here as land can be bought cheap and a full and complete water supply could be had from the Rio Grande del Norte, and the putting in of a canal would be a profitable business enterprise.

Most of the land along the river in these valleys is held in old grants and is about to get out of the old Mexican ways have been made until the "Mormons" came in. Last year the first harvest was put in operation and the Mexican population looked on it

with suspicion. All their work is done in a primitive way. Now when winter irrigation should be going on, their ditches are empty, and the streams are full of water. A larger and independent ditch is necessary so that fall and winter irrigation may insure good crops. The markets are good and this is a fine fruit country. Elder D. G. Russell is the prevailing idea and there are some good people here.

Elder J. A. Meloy and Elder Cox, of the New Mexico conference, have been visiting the branch recently.

The leading Americans in this part of the country feel to give our people every encouragement and there is no reason why they should not grow in numbers and wealth.

The weather is warm and pleasant, no snow or ice. Ground in good condition to plow.

Our irrigation company has laid out considerable work in grading and improving our canals; strengthening dams, etc., that will keep us out of mischief until some other attraction presents itself.
