A Temporary Victory for the Republic
Not in the Senate.

WASHINGTON, Sept. 6.—In the Senate, Crittenden introduced a bill to equal all acts for the creation and maintenance of a sinking fund. He failed.

Resolutions were reported from the committee on privileges and ethics, granting \$2000 each to John H. Allen (Washington), Law (Montana) and A. G. Beckwith (Wyoming) for their work in procuring their names to read in the Senate. Resolutions were also introduced by the committee on contingent expenses.

The resolution was therefore laid over, when the resolution of Morgan, also, providing for a joint committee of finance, was laid before the Senate.
