**Local and Other Matters.**

FROM TUESDAY'S DAILY, AUG. 19.

**Receding.**—Arrivals from Silver Reef report matters very dull in that erst lively camp. It is said to be fast receding.

**The Courts.**—The Supreme Court of the Territory opens its new term on Friday, the 22d inst.

The District Court will follow suit on the 1st of September.

**Attempted Suicide.**—A man named Matthews in the First Ward, attempted suicide on Sunday, by taking an overdose of laudanum. The cause was heavy drinking, for which his wife had upbraided him. On ascertaining his condition, his better half procured medical aid, and the would-be suicide was restored.

**"Enquirer" Items.**—Last week the Provo Factory shipped 1,500 pairs of woolen blankets. (It must have been to Iceland, then.)

Diphtheria is raging at Panguitch Lake.

Baled hay, along the line of the U. S. R. R., is worth from \$15 to \$16 per ton.

The owners of the Pleasant Valley railroad think they can deliver coal from Spanish Fork Canyon at the Springville depot for \$4.50 or \$5 per ton.

**Wm. Carson, indicted for burglary in the First District, who cleared out about nine months ago on hearing of the court's action in his case, has been arrested at Deseret by Sheriff Huntsman, of Fillmore. He will probably be released on \$1,000 bonds.**

**Shocking Accident.**—Last night's Dispatch records, under this caption, a frightful accident that occurred Sunday night, to one Daniel W. Shell, on the Union Pacific railroad, six or seven miles west of Corinne. He was beating his way over the road, had boarded train No. 8, and was running along on the box cars to speak to the head brakeman, when he fell down between two cars. The train was stopped and several of the employees went back to find the unfortunate man. They met him coming along the track with his arm broken and dangling at his side. He was taken to Promontory, put aboard an emigrant train and brought to Ogden, where he received medical treatment.

**Fires in Ogden.**—From the Dispatch, we learn that yesterday morning the Catholic Church in that city took fire in some unknown manner, and had it not been for the effective service of the fire brigade and other citizens, would have been destroyed. The fire started in the vestry, and is conjectured to have been the work of tramps. A Chinaman living near by was the first to give the alarm. The loss is small.

A cigar stump dropped through a crack in the platform near the Union Depot Hotel, yesterday morning, came nigh causing another fire. A gentleman seeing smoke and flames issuing from beneath the plank, gave the alarm, and the incipient blaze was quickly extinguished.

**Accidents—Farewell.**—On Sunday the 10th inst., Misses Sylvia Merrill and Elizabeth McCann, of Smithfield, were thrown from a horse, the former badly hurt, and the latter severely bruised. Two other girls, riding another horse, struck the animal on which their companions were seated, causing it to jump and throw them off.

The Sabbath before, a little nine year old son of Thomas Rogers, of

Benson, while riding a horse with a rope around the saddle horn, was thrown off, caught in the rope and dragged quite a distance. He was insensible when found, but will recover.

The Northern Light, from which the above items are taken, is the last number of that paper, the company having been induced to go and set up a journal in Oxford, Oneida County, Idaho, under the title of the Idaho Banner.

**Returned.**—The many friends of Sister E. R. Snow will be pleased to learn that she has returned from her six weeks absence up north, looking and feeling in excellent health and spirits.

**Severe Mishap.**—The Junction states that on Sunday Mr. F. J. Kiesel, of Ogden, while getting into a buggy, was violently thrown to the ground by the horse suddenly wheeling to one side. Mr. Kiesel was insensible for a long time after the accident, but is now recovering steadily.

**Deseret Museum.**—The curator respectfully acknowledges the receipt of the Bulletin of the Salt Lake Academy for 1879-80. Also an Opussum, donated by J. C. Harper, Esq., of Payson, and forwarded by the U. S. R. R. to the Museum, by Mr. J. L. Townsend, chemist and druggist, of Payson City. The curious animal arrived in safety last evening, and seems to enjoy herself in her comfortable quarters in the Museum.

**Equalization of Taxes.**—On Tuesday, the 26th inst., at 2 p.m., the City Council will convene at the council chamber of the City Hall to sit as a board of equalization, to determine all complaints made in regard to the assessed value of any property for the present year. The board will also, during its session hear and consider all petitions for the remittance or abatement of taxes assessed the insane, idiotic, infirm or indigent, to an amount not exceeding \$5, for the current year. **Accidents.**—Several days ago a little eight year old son of Brother Gibson, of Sugar House Ward, while at Coalville with his older brother, met with a serious accident by stepping into a bed of burning slack and ashes. Both legs were badly burned nearly up to the body and both arms nearly to the elbows. At last accounts the little patient was in a critical condition.

Last Monday evening the older brother, while driving a team within a quarter of a mile of his home, was run into by another team and his leg broken just above the ankle by the collision. Medical assistance was summoned, the injured limb reset, and the young man is now doing pretty well.

**Died from His Accident.**—Daniel W. Shell, the victim of the fearful mishap on the Central Pacific Railroad, Sunday, in consequence of which his arm, which was broken in three places, had to be amputated near the shoulder, died from the effects of his injuries at 3:30 yesterday morning, at Ogden, where he has been staying since the occurrence.

It now appears that injustice was done by calling him a tramp and a "beat," as he had money on his person, had paid his fare all the way along, and is respectably connected in Union Depot, Sullivan County, Tennessee. His parents were informed immediately of the sad event and sent back word for his remains to be buried in Ogden until the arrival of the father to take them in charge. This was accordingly done yesterday afternoon.

**For the South.**—Elders Erastus Snow and John R. Morgan, left for the South this morning; the former to visit the Saints in Colorado and New Mexico, the latter to Georgia to resume charge of the Southern States mission.

**Missionary Notice.**—The missionaries called for Scandinavia, expecting to leave in September, will make their arrangements to be in this city on Sunday, Sept. 7th, to leave by train on Tuesday morning, Sept. 9th.

**A New Paper.**—Mr. Frank J. Cannon, of the Ogden Junction, came down to the city last evening and returned north this morning. He will shortly go to Logan to take charge of the Leader, a weekly to be conducted in that city under the auspices of the Junction Printing Association. Success.

**Eye Removed.**—Dr. J. M. Benedict, of this city, and Dr. O. C. Ormsby, of Logan, went to St. Mary's Hospital, this morning, to remove the eye of Mr. Murphy, which was so badly injured by a blast, in Beaver Head, Idaho, a few days ago, as to require the operation.

**Will Defend Himself.**—We had a call this morning from O. C. Ormsby, Esq., the popular physician and surgeon of Logan, Cache County, who is spending a few days in our midst. He informs us, in regard to the suit to be brought against him for malpractice, that he has the confidence and sympathy of the leading medical professors in our community, and has engaged the best legal counsel to be obtained, with the intention of defending himself against what he considers an unjust and malicious action.

Dr. Ormsby's reputation for talent and skill in his profession, has always been excellent, and we sincerely hope and believe that he will clear himself of the imputation now cast upon him.

**"Dispatch" Notes.**—Thirteen car loads of railroad iron left Ogden on Tuesday, for the Utah Southern extension.

The statement that the parents of Mr. Shell who died in Ogden Tuesday morning, had been informed of his death, was incorrect. No communication had been held with them.

Dr. Whittier has been testing the newly discovered Utah saltpeter, and finds the blasting powder made from it to be of superior quality.

The Workingmen's Co-operative Boot and Shoe Manufactory of Ogden was entered by burglars Tuesday night, and about \$70 worth of boots stolen.

The Union Pacific pay car arrived in Ogden yesterday forenoon and paid off the employees of the road.

From the "Enquirer."—The B. Y. Academy resumes on Monday next.

The postmaster at Castle Dale complains that, although there is a regularly established postoffice there, no mail has yet been delivered. What's the matter?

Tuesday morning Mr. Wm. Park, of Provo, took a dose of epsom salts and was thrown into violent convulsions. Some of the salts from the same package were analyzed by Dr. Pike and some fine crystals found, supposed to be strychnine. These were given to a young cat which lived but a few minutes after the experiment. Salts from the same package poisoned William's brother John, seven months ago, who is just recovering from the effects of the accident.

**A Nice Operation.**—Yesterday, Dr. W. R. Pike, of Provo, assisted by Doctors J. M. Benedict and O. C. Ormsby, performed a very skillful operation on the person of Mr. David Dibble, of Springville, by which the right leg was amputated above the knee. The injury which necessitated the removal of the limb, was sustained about 14 years ago, the ankle being fractured and the bone of the foot dislocated, so as to require the patient's walking upon the end of his toes. The compli-

sory use of the knee, for divers purposes, thenceforth, caused the inflammation of that joint and eventually demanded the amputation. The two assistant surgeons speak in high terms of Dr. Pike's operation, the first of the kind in his practice. He is a young practitioner of skill and ability and will doubtless attain to eminence in his profession.
