The attention of the members of the Reorganized Church was by this incident called to the fact that the leaders of that church had been misrepresenting the facts in regard to the ownership of the lacts in regard to the ownership of the Temple lot, and at the April conference of 1891, an explanation was asked for. This called forth the statement that the Reorganized Church had the title, but the 'Hedrickites' had possession of the property, that there was a cloud on the title which could easily be removed, and the church would get possession of that property as it did the Kirtland Temple. The conference promptly instructed the The conference promptly instructed the bishopric to take the necessary steps to remove the cloud from the title to the property in Independence. In accordance with that instruction suit was commenced in the U. S District Court at Kansas City in September, 1891."

If it had not been for the vigilance of the Hedrickite President, the trick by which the "Josephite" Bishop endeavored to appear officially as the owner of the Temple lot as trustee for his sect, would have prevailed and an appearance of title to the land would have been made. The "Josephites" gained possession of the Kirtland Temple by a bold stroke and because the suit went by default, the Church in Utah not making an appearance in the case. Success in that instance has emboldened the "Josephite" leaders to take steps to grab the Temple grounds in Independence, to which they have no more moral right than to the private property of any citizen of Missouri. The intrinsic present value of the land is not much, but its historio and prospective worth is great in view of past incidents and future expectations in connection with that sacred spot, which is the centre of attraction for many thousands of Latterday Saints.

## MILLS IN THE SENATE.

Reagan's unexpired term is only one year, so that if Mr. Mills desires to succeed himself he must prepare to enter another cam-

paign in a few months.

In the contest just closed he had two formidable competitors, Judge Culberson and Senator Chilton, and in the next they will also be in the ring. it is said that the next canvass will be conducted after the manner in which Senator Palmer of Illinois was chosen. The entire State will be can vassed and the United States Senatorship made an issue in the campaign during the election for members of the State Legielature.

Senator Mills is an able man, an actual worker, of great nervous force, aggressive, hut courteous, persevering but patient, a strong politician, and a shrewd, alert and liberal legislator. He was a prominent man in the House and will not be silent in the Senate. He is a great accession to the Democratio minority in that body.
