REED GETS CHIEF OF THE BARS

Ex-Convict Released One Week Ago Landed While Entering Reed Home.

HAS MADE A CONFESSION

Theodore Resident Wants Authority For Settlers to Organize Districts.

Residence Ransacked, But Prisoner Denies That He Turned Trick Or Had an Accomplice.

Nightwatchman C. C. Riley, who patrols east South Temple street, did a good piece of work last night and landed an ex-convict behind the bars. In making the arrest Riley prevented the ex-convict from breaking into and robbing the residence of H. W. Reed, 777 east South Temple street. The man arrested proved to be Gus Norstrom, alias Leonard Ryan, who was released from the state prison on Saturday after serving a sentence of 18 months for burglary.

After Norstrom was taken to the police station he admitted to Chief of Detectives Sheets that he was in the act of breaking into the Reed home when Riley placed him under arrest. An examination of the house showed that it had been entered and all the rooms thoroughly ransacked, but Norstrom declares he did not do it and that some one else must have "busted him in." The police believe the man had a confession to make. Norstrom is out of the city, but was notified by telephone last night of the robbery.

It was shortly after 8 o'clock last night when Chief of Detectives Sheets, who had been standing in the shadows of some trees in front of the Reed home, Riley watched the man and soon saw him steal toward a window. The fellow was carrying a satchel and a revolver, and Riley saw him throw up his hands. Norstrom offered no resistance whatever but rapped loudly on the window. It is believed he had a pal in the house was giving him a signal to get away. Norstrom stuck to it that he did not have a companion and said he did not know the house had been entered.

TALK OF AUTO SPEEDWAY

One Thousand Owners Will Be Asked To Subscribe \$100 Each To Construct Saltair Boulevard.

Are there one thousand owners of automobiles in Salt Lake who would be willing to put up \$100 each for the building of a private automobile speedway way to Saltair? And for the speedway it is said that it would be 39 feet wide, with 10-foot slopes on each side, would run over one of the finest level stretches in the country, and would afford opportunities to open the road to the limit with never a need to fear a sunken chuck hole or a bumpy crossing.

The boulevard to Saltair was the principal thing discussed at a meeting of the Automobile club directors at the Commercial club last night. Besides deciding on the plan of issuing stock in the boulevard, the directors of the club decided to go over the route at once and see just the nature of the construction problem. A committee, consisting of Ben Davis, E. D. Miller, M. D. Dwyer, O. H. Heston, F. J. Westcott, Dr. W. F. Beer, and J. E. Langford, was appointed to go over the course at once, in company with a number of practical engineers.

The name of the club was changed from the Salt Lake Automobile club to the Automobile Club of Utah, to make it state-wide in scope, and for the same reason the initiation fee was dropped from \$10 to \$5.

A bill to be submitted to the legislature providing for the registration of automobiles, was discussed and referred to a legislative committee, for action to be taken by the legislature. The bill in part is as follows:

Section 1. Every owner of an automobile shall, for every such vehicle owned by him, file in the office of the secretary of state a statement of his name and address, with a brief description of the vehicle to be registered, including the name of the maker, factory number, style, year of manufacture, and type of motor, and a statement of the name and address of the person to whom the vehicle is being sold, and the name and address of the person to whom the vehicle is being sold.
