Councilor Harrington, Chairman of the Committee on Printing, presented the following report: "Mr. President and members of the Council:—The Committee on Printing, to whom was referred the House concurrent resolution, ordering the printing of 500 copies of the Journals of the Legislative Assembly, beg leave to report, with resolution back with the following amendment. That it read 200 instead of 500. And recommend: 'The passage of the resolution as amended.' The report was read and accepted.

The resolution was passed as amended. Councilor Harrington presented Titles 10, 11, and 12 of "The Penal Code," adjourned.

Petition of Deseret National Bank and twenty-nine others, requesting that the four crossings at the intersection of East Temple Street and First South Street be raised; referred to committee on streets and alleys.

Petition of F. W. Stephens, for leave to occupy a portion of the street and sidewalk in front of the Nixon property, East Temple St., for piling building material for the new building; granted.

Proposition from Eastman and Goutier to sell to the City, for \$2,000, the rights to use their patent water-closet, referred to committee on improvements.

The special committee who were authorized to negotiate with the Salt Lake City Gas Company with regard to the purchase of stock to the amount of \$50,000, reported the following resolution, which was adopted:

"Be it resolved by the City Council of Salt Lake City, that the Treasurer be and is hereby authorized to receive from the Salt Lake City Gas Company, a certificate of stock to the amount of \$50,000, in full payment of the said company's promissory note, amounting to \$50,000, to take effect on the first day of January, 1878. Provided, that all interest due on said notes at 12 per cent per annum, and all interest in excess of 12 per cent per annum, and costs incurred by the City in obtaining funds for advancement of said loan or any part thereof, shall first be paid by said Gas Company."

It was decided to bid the residents of the 1st, 2nd, and 10th wards in constructing a dam at the mouth of Emigration Canon, by appropriating 2,500 feet of lumber for that purpose.

The committee to whom was referred the petition of Dr. B. R. Young, offering to lease the hospital and insane asylum, recommended that those institutions be tendered to the Territory, on reasonable terms, adopted, and the committee were instructed to confer with the subject with the committee of the Legislature, who had the recommendation in Governor Emery's message on the matter under consideration.

Remonstrance of Auer and Murphy, and twenty-nine others, proprietors of the vicinity of Utah Western Railroad, against the proposed extension of the line, was read, and asking that the railroad company be required to remove it; referred to committee on streets and alleys.

The committee on municipal laws presented a bill for an ordinance regulating the sale of drugs and medicines, and for an ordinance in relation to building over within the limits of the corporation laid on the table to come up in order.

Adjourned till next Tuesday at 7 p.m.
