The Chamber of Commerce Issues a Patriotic Address to the People.

TRUSTS WILL BE CONSIDERED.

Mass Meeting of Citizens to be Held at the Salt Lake Theater. Everybody Turn Out!

To the Public:

The election is over and it is now high time for us to make a united effort to promote general prosperity.

Our great sugar industry is engaged in an unequal struggle with a mighty trust, which seeks to crush it out of existence. The Utah sugar crop amounts annually to a quarter of a million bushels. This number belongs to us, our families and laborers, and the success of the trust must fail. We are paying annually in tax money nearly \$200,000 for sugar, although great railroads are within our borders.

Utah is standing at the door of Statehood. The change from the Territorial to the state form of government will have a pronounced effect upon our business interests in that respect. That it will remove from operation the "alien land law," which now prohibits the investment of foreign capital in the state.

That it will enable us to increase our companies more easily by the terms of their charters from investing in the Territory to place their funds in Utah.

That it will induce investments here of funds from foreign countries. The Territorial form of government have closed their eyes to the opportunities here offered; and that's all that's needed to a large emigration of people who will be attracted here by the climate and opportunities which always comes to a new state. Therefore the time is propitious for work. Let all the people enter into co-operation to hasten the realization of that Utah's destiny. We have been won over to this cause by the principles of the little, wise and unostentatious when he relates. The Chamber of Commerce takes initiative and invites all patriotic-minded men of whatever complexion to meet at the Salt Lake Hotel, November 10, at 10 a.m., to discuss ways and means to promote and hasten our industries, to secure to us cheaper rates of fuel, and to promote general interest in advertising our products by whatever means the same may be used in this country. This is a great event in our history. The speakers will be in attendance, and everybody will have a chance to express his opinions and offer suggestions.
