## NELSON'S REPRISALS.

They Formed of the Chief Topic in Ogden at This Time.

The alleged defalcations of A. H. Nelson formed the subject of much conversation on the streets of Ogden yesterday. To many of his former friends the thought of his being an embezzler seemed incredible, while to others the master accused seemed little, if any, scruple, as it was known last June, when the election of a new board of directors and officers was held, that there was something amiss in his accounts. At that election Nelson was chosen as secretary of the association for the reason, that the board of directors, at their election, had voted that he had been openly blighting this society for a consecutive time.

As in Nelson's departure, so in other fields, there is a diversity of opinion. He was soon on the wing again, and was soon on the road, and was soon on the corner of Twenty-third and Washington streets at 11 p.m., on his way to Ogden until late Monday evening, and it is believed he has taken the train to Salt Lake.

It is believed that there is no agent of the express company, and consequently the express charges would necessarily have to be prepaid. As no money was left in his possession, the baggage was remitted by railroad express, and it now remains stored in a back room—away from the owner.
