The Chinese Question.

NEW YORK, 28.—The Times renews the decision of Judge Deady in the Chinese case, saying, the Chinese are a race of slaves. The Chinese are unhappily inclined to assist, with superfluous passion, that nobody but a dweller in some of the Chinese cities could be qualified to express an intelligent opinion on the Chinese question. In California, we understand, it is necessary that one should establish a reputation as a planner, the man who arrived on the coast prior to January last, 1849, before he gains the right to entertain an opinion on the Chinese question, a subject, as far as Judge Deady is concerned, he might to live in this country carries with it the right to work for a living, the anti-Chinese papers are full of the same kind of reasoning, not good law. At least one of them says that "this is an assumption which may be determined by law." The right to live is a right which the right to earn a living may be implied from the terms of the Burlingame treaty, which concedes the right to live, this implication is not a right to earn a living, it is a mere prohibition. That is to say the right to earn a living is only implied in the treaty, while the prohibition excludes the right to earn a living. This is the theoretical prohibition which we oppose, we were not prepared to discuss the question when we were told that the Chinese were to be excluded from the United States between the right to spend their money in this country, and confining upon them the right to come here and make money, we were told that the right to spend their money for so called and ingenious a plan.

Germany Trying to Impose on Japan.

LONDON, 20.—The German quarrel with Japan is said to be getting more serious. The German government has recently authorized by the German envoy to the Mikado, to break the cholera blockade at Yokohama, in consequence of which Japan has changed the cholera regulations between Japan and the Christian powers. America sides with Japan, but England supports Germany.

With African News.

A dispatch dated Cape Town says: Yesterday left Port Durford on the 4th inst. Quarters have been prepared for him at the castle there. All the remaining hostile tribes in Zululand have surrendered. Sir Garnet Wolseley arrived at Utrecht, Transvaal, on the 7th instant.

Rusian Fires—Rinderpest.

Russian official messengers state that 2,957 fires occurred in Russia during August, causing damage to property to the amount of twenty million roubles.

The rinderpest has appeared near Koenigsberg. The disease is extending into Russian Poland.

European Notes

A Berlin correspondent hears, from a good source at St. Petersburg, that the German ambassador at St. Petersburg, at Livadia, between the ambassadors from London, Paris, Vienna, Constantinople, and Athens, and the Counselor For Giers, of the Russian Empire, Count Giers, the minister of war, and General Kauffmann.
