

MONEY TURNED OVER

District Court Clerk Stanton Gets a Big County Warrant,

10 BE PAID TO THE STATE

For Court Fees—Supreme Court Decides Against Police Officer Frank McDonald.

This afternoon County Auditor Peter issued a warrant to Charles E. Stanton, clerk of the Third district court, for \$1,250.00 in payment of state's fees necessary turned into the county treasury. This will be turned over to the state treasurer in payment of the principal and interest claimed by the state. The warrant, however, does not include the amount of damages prescribed by law in case of deficiency—20 percent and amounting to about \$3,000—and the probable that its payment will be insisted upon by the state.

If Mr. Stanton or the county pays this money the next legislature will probably make no appropriation for the cost of attorney fees paying, amounting to the deficiency of Mr. Stanton covered by state.

Against McDonald.

Court Justice Hines in the Supreme court today handed down an opinion, rendered by Justice David M. Donaldson, affirming the judgment of the inferior court.

The defendant was indicted for assaulting one Frank McDonald and was found guilty and was bound with a heavy weight of 100 pounds. On trial he denied the commission of any offense under the indictment, and also a motion for a new trial, and the sentence, the defendant appealed. He argued that the facts described in the indictment and in admitting evidence under it.
