son why the "Mormons" should do likewise; but they do not. Many of them are as anxious to have their children religiously trained as "Mormons? are.

The object of the Commissioner, who is a fanatical Methodist, iu making so ridiculous an assertion, was to avoid including non-"Mormon" sects in his denunciation of religious schools, as tending to cripple the public schools, that he might confine that censure exclusively to Latter-day Saint educational institucions. His complaint against religious schools is a gratuitous departure from his duty, and the language he employs is offensive, not to say ungentlemanly and insulting, to the majority of the people of the Territory. To publish it would be to create unjust prejudice against them, and the committee on education did right to recommend the striking out of the objectionable religio-political feature of a report, which should not seek to make political capital for any party. An official report should be free If it is from demagoguery. not it should either be ignored or the demagogie portions stricken out. It is bad enough for the people to have an objectionable public officer thrust upon them without their representatives undertaking to aid him in his efforts in the role of a machine to discharge insults at those who pay his salary. The effort of a small minority of the Legislature to aid this objectionable and very small-souled official in that capacity taints them with a similar hue.
