#### SUNDAY SCHOOL CONFERENCES.

# Beaver Stake.

The annual Sunday school conference of the Beaver Stake was held at Adamsville on Saturday and Sunday, the 10th and 11th of September, 1898, presided over by Stake Superintendent Wm. Forhterinham. Elder L. John Nuttall and W. B. Dougall of the gen-eral Sunday school union board were in attendance, and gave much valuable in-

struction on Sunday school topics.

There was a good representation of superintendents, officers and teachers. also a goodly concourse of children, with their parents, present.

The reports of the superintendents of the schools in the Stake indicated a general effort to comply with the rules laid down in the "treatise," and the exercises of the different classes evinced careful and efficient work on the part of the teachers. the teachers, and aptness by the pupils.

One beautiful feature of the exercises was the recital of the Articles of Faith by the congregation, led by a class from

Minersville Sunday school.

At the teachers' meeting held at noon on Sunday, Elder Dougall made some expressive remarks on the subject of marriage, showing the necessity of extreme caution on the part of young peoplein the selection of hushands or wives, not only for the good of this life but that salvation in the life to come may

that salvation in the life to come may also be secured. Elder Dougall spoke upon the same subject in the afternoon. Elder Nuttall spoke at some length upon the importance of early training of the youth, and the necessity of surrounding them with moral influences. Elder Dougall enlarged upon the responsibility of a teacher's calling, and claimed that a call to that once should not be ignored or treated lightly. He also strongly deprecated the practice of also strongly deprecated the practice of many theological classes taking up and discussing subjects utterly beyond their capacity, and which are entirely irreva-lant to the study of the Gospel.
