duty it shall be to take and hold possession thereof, (receipting for the same,) until the owner or owners thereof shall take the said liquors out of this city, or place the same in the hands of the aforesaid physician or physicians for sale, as above specified.

Sec. 3: The marshall having received into his charge any liquor, shall forthwith in the presence of the owner proceed to have the same inspected by the city inspector of liquors, who shall put the proof-brand or mark on each barrel, keg, or other vessel,

containing said liquor.

Sec. 4. Any person or persons neglecting or refusing to comply with this ordinance, shall be liable to pay a fine in any sum not exceeding five hundred dollars, and forfeit all liquors owned or brought into the city by them.

Sec. 5. This ordinance to take effect, and be in force from and after the first day of

July, 1851. Passed, June 23, 1851.


