SENATE.

WASHINGTON, 19.—The supplement

ary bill was taken up to incorporate the

Texas Pacific railway. Hamilton, of

Texas, opposed the bill, and said the

and day out; sometimes wisely and

sometimes unwisely. It has been pros-

ed home to the mind and the conscience

with ability and earnestness. The pro-

vince of argument, logic, appeal and

infective has been thoroughly invest-

ed in behalf of its claims. Still the evil

remains. The same disregard of the

conclusive demonstrations which truth

has made active against intemperance

continues to show itself among men.

The same disposition exists to kill time

and indulge in the transient pleasures

supposed to reside in the flowing bowl.

It shows itself in a vacillating, unrest-

ing life, and in all the heart-rending

details which cluster in the wake of this

evil.

In conclusion we have only to add,

the constant recurrence of the same

facts demand the repetition of the same

truths. The same necessities call for

the same returns. If we cannot origi-

nate newer and better plans we must

content ourselves with the old and

tried. Would that the work were done

better, but better, perhaps, as it is, than

not at all.—Washington Gazette.

UTAH.

SALT LAKE CITY, April 9, 1872.

To the Editor of the Herald:

Enclosed are proceedings of the first

Democratic meeting held in Utah for

the organization of that party. The

Republicans have already shown their

disposition to oppose the movement, and

the Democrats have already shown their

disposition to support it. This movement

of the Democrats has originated wholly

among Gentiles and has been conduct-

ed by them, while not a few Mormons

are interested spectators of the rally.

The Legislature of the new State of

Deseret have recently elected two Rep-

ublican U. S. Senators, and the people

have chosen a Republican representa-

tative to the House in the person of

Mr. Frank Fuller, but in a fair open

field fight the Democrats are ready for

battle. In the approaching general con-

test for President and Vice Presi-

dent, they cannot remain passive look-

ers-on, but they propose to be known

and heard by the members of the

party throughout the Union.

The false, exaggerated statements em-

anating from the associated press agents

in this city, and from the columns of

the press, give such an incorrect rep-

resentation of affairs here, both polit-

ical and social, that the American pub-

lic are everywhere misled and deceived

and, under the influence of the law-abid-

ing and peaceable community in all the

territories of the Union. In the esti-

mation of these fellows—who at best

are a run of cattle, thinking for the

handling of the city treasury for free

drinks, and for a fight—nobody has a

right to peacefully abide and work here,

unless he will fall down and blindly

worship the dragon of the federal offi-

cial, and declare amen to all the usur-

pations and mal-administrations of their

feudal judges and officers of their

court.

maintained at the cost of the moral ruin

of its servants. Certainly the pub-

lic amusement is not such an interest.
