CHICAGO, May 20.—A special to the *Times* from Indianapolis, Ind., says: The Populists of Indiana have taken the announcement that within the last few days an understanding has been reached between the Populists of every state in the Union, as to accept the platform and candidate of the Chicago convention in case such a free coinage silver.
