Lillian Waters, the girl who has attracted much public attention lately, returned home again early this morning by turning on the gas in the heating hospital at San Jose, Cal., where she had been confined since Saturday afternoon, when she came to San Jose to seek medical aid for her menstrual trouble. The girl was carefree during her convalescence.

Her parents reside at Santa Cruz.

William Ellis, right engineer of the passenger train of the Arkansas and Oklahoma Electric railway, Cal., came near losing his life last Saturday evening. In company with Assistant Superintendent Duperre, he was at work repairing a switchboard, when he accidentally touched a short circuit. He ran into the air and the current passed through his body and through Duperre's. It was supposed at first that Duperre was the most severely injured of the two, and he was taken to the nearest hospital, but yesterday it was learned that Ellis received the most severe shock. It is believed that both were not killed, as they received a charge of 5000 volt. Ellis is at home at Elkhorn under care of a physician, and it is hoped with sufficient treatment will effect a full recovery. Both men were taken to the Arkansas electric company, and, as far as can be learned, no electric shock ever did so much damage as that received by Lillian Waters, the girl who saved their lives. The fact that they were standing in dry houses instead of on a piece of iron or wet planks.

The H. P.
