said that he had been looking and praying for some of the Elders of the Church of Jesus Christ of Latter day Saints to be sent to him that he might hear what they preached, for as yet he had heard nothing of their Gospel but from the rumors of the enemies of this people. He told us who he was and we gave him our cards, put away all wegave him our cards, put away all formalities and began a conversation on the Gospel. He had been a minister in the Free Will Baptist church, but found that the doctrines of Christ were not the same as they had in that church, and he could not consistently preach anything contrary to the doctrines of our Lord. There being a branch of the Reorganized Church of Jesus Christ of Latter-day Saints in that vicinity he began to investigate their faith, and found it to be more according to the Scriptures; accordingly he embraced their doctrine and joined, but soon after he began to see that they did not have the authority to perform the ordinances of the Gospel according to Daniel the Prophet, who says that a small stone should be cut out of the mountains without hands and should roll forth till it filled the whole earth and should never be thrown down or given to another peo-

It was when his mind was struggling and pondering over these things that he began to pray for the Elders to come to him or where he could find them; and you can plainly see how easy it was for the Lord to cause that we should become lost in the words and then lead us to this man. "God moves then lead us to this man. in a mysterious way, His wonders to perform." Upon invitation we went to the home of this man and there we explained the principles of our taith, answered questions which he asked of us; and proved to him that we did have the authority to preach, teach and officiate in all the ordinances of Christ.

We held a meeting at his house that night and the next afternoon and evening, after which he applied for bap-tism, as also did his wife a tew days later. His wife had a dream just be-fore we came there, and when she saw us she said we were the same men that were shown to her in the dream, and the words we preached were the same also; and this convinced her heyond a possible doubt. They are now both earnest workers in the great cause of truth, for which we feel to give our Heavenly Father all thanks and praise. In and of ourselves we could not have found these people.

Every day some great blessing is given us to show that God is watching over His Elders who are working in His vineyard. We feel well in our labors and are willing to go on in the great work of spreading the Gospel till every creature has had the privilege of hearing the word of God, and none are hearing the wolleft with an excuse.

HARTSELLE, Morgan Co., Ala. August 1st, 1896.

Never a month passes but it has brought forth incidents of a fresh and invigorating kind. Chief among these last month were some cases of the healing of the sick. One case worthy of special mention occurred on the morning of the 23rd ult. At the solicitation of a number of friends, Elders John

Hancock, Arthur Smith, Rodney B. Ashby and myself carried on a series of eight meetings near Woodland Mills, Morgan County, Alabama. The people of the neighborhood took kindly to our doctrine. At first they filled the house; but during the last two or three meetings, for lack of room, about half of the congregation was forced to remain outside. The lady in question was especially eager to hear our teachings. though her family was large, thus creating much work for her, she rushed through her household duties and came out to every meeting. Doubtless it was her work, excitement, hasty eating, etc., which proved too great a strain for her system. At the last meetings she had forebodings of illness. We walked to their home with herself and husband, then went to the home of Mr. James Cook and retired for the night. Perhaps not less striking than this was the effect on the people who witnessed the miraculous display of God's power in the healing of this woman. There was an influence, which penetrated the hearts even of the unbelievers present, causing them to yield, to break down, and to acknowledge with tears of praise the name of God.
