TWO BONIS TOO MUCH FOR PRINCE

Anna Gould's ex-Husband Holds Prince Helie de Sagan Down While Brother Kicked Him

ROW STARTED IN A CHURCH.

For Christmas Present Count Spat in His Face-Will be Settled in Courts Not on Field of Honor.

Paris, Jan. 2 .- Count Boni de Castellane, from whom his wife, who was Miss Anna Gould of New York, Was recently divorced, and Prince Helie do Sagan, who on several occasions was reported to be engaged to Madame Gould, had a personal encounter today at the Church of St. Pierre do Chatilot while a service to the memory of Lady Stanley Errington, a relative of both men, who died lately in England, was in progress.

Beginning inside the church, where Count Boni says the prince insulted both him and the sacred edifice, the encounter was resumed at the door-way, where Count Boni, followed by his brother, Count Jean de Castellanc, overtook the prince. Count Boni spat in his cousin's face. Then, came the clash of canes, followed by a rougn and tumble fight on the pavement, which ended in the gutter, where the men were finally separated by a big butcher. Count Boni at the moment of intervention was holding down the well-nigh insensible prince, while Jean, according to eye withesses, was admin-istering to him a severe kleking. PRINCE WAS BLEEDING. With the butcher's hand on ms collar, Boni was haranguing a crowd which had gathered as to way he had spat in the prince's face. The police invited the two men to go to the stat-tion house, and this, after some disput-ing, they agreed to do. All three of them, bespattered with mud, accompanied the police, and foi-sowed by several thousand persons, they marched off to the station. Both Count Boni and the prince gave their own version of the quarrel, each

their own version of the quarrel, each claiming that the other was the ag-gressor, but the prince alone lodged a complaint, charging the brothers with

A "process verbal" having been written out, according to the French law, the three men signed it and were then released. The case now will go before the public prosecutor, who will decide what steps shall be taken.

Count Boni said he took no notice of the prime during the services, which pro-ceeded without incident until the eleva-tion of the host, when the prime rose.

Boni and Count Jean de Castellane on the theory that Boni was a madman. He therefore could not appeal to the code, he said, but would let the case take its course in the criminal court. He declared that the attack was en-threly unprovoked. He was sitting in another part of the church, far from Count Boni, and when he left as the service was concluded, Boni and his brother followed him out. As he reached the steps of the church he was seized by the shoulder, and, wheeling around, he found himself face to face with Count Boni, who uttered the around, he found himself face to face with Count Boni, who uttered the words, "This is a Christmas present, my child," spat toward him, when they closed, he said, after the first exchange of blows, his foot caught in his long, heavy overcoat. He tripped and fell on the curb, and it was then that Count Boni and his brother pounced upon him, kicking him and beating him with their canes. As it was evidently a was not engaged to Madame Gould. He said that he would willingly fight a duel if there was honorable provocation, in-cidentally mentioning his proficiency as a swordsman, but under the circum-stances he intended to allow the law to take the curves

Washington, Dec. 31 .- Many bills have been introduced by each branch of Congress this session relative to the good roads movement that has been started in this country. One by Representative Clark of Florida provides that the secretary of war shall have a road built and constructed in each state and territory 100 miles in length and 20 feet wide. The bill also provides that army

ngineers shall be put in charge of the

engineers shall be put in charge of the work. As a starter Clark suggests, an appropriation of \$5,000,000 to begin building hard surfaced highways. These measures are all referred to the com-mittee on agriculture. Before the Civil war Uncle Sam commenced to tuild a great national road. Some of the con-gressmen insist in their bills that that project shall be first completed.

There is a gradual tendency on the part of senators and representatives to make an illustrated publication of the Congressional Record. No one has yet attempted to print pictures in this or-gan of the statesman, but the other day the older and more dignified members of the subern senate were really shock. the older and more dignified members of the solemn senate were really shock-ed to discover that Mr. Tillman of South Carolina had printed along with his remarks on the recent bond issues by the treasury facsfinilles of clearing house certificates that have been clr-culated since the money market became tight. There was also one in the bunch stamped "lumber money," issued by a company dealing in that product. With-in recent years a number of maps have been printed in the Record. The ques-tion is being asked as to how far this thing will be carried. One senator was heard to remark: "If a stop is not put to this sort of business at once, it will not be long before the Record will con-tain caricatures of the political situa-tion. If there is justification for print-ing clearing house certificates, why not go extensively into the picture business, add the funny things that are said about the subjects and make a real comic publication of the Record? That might make it more sought after by the public, perhaps. Then Uncle Sam could build up an enormous circulation and come in direct competition with the funny papers."

Although it is not the cus-tom to issue the orders on Sunday, many offices have to do it as a matter of accommodation to patrons who can-not visit the towns during week days. tion. The executive committee, the uniform lesson committee, the Sunday school edi-torial committee and the demoninational publishing concerns of the country were represented in the assembly of the lead-ers who are authorized to speak for near-ly all the demoninations of the Christ-ian churches, representing some 14,000-000 members.

000 members. The topic for discussion is "How can we improve the lesson system?" The international lesson committee, prompted by action taken at the last tri-emial at Rome in the spring of 1907, has had under consideration the ques-tion of changing the system to meet advancing conditions and there has been much discussion of plans by members of the editorial association and the publish-ers of the lessons of the variou demonia tions.

tions. While various conferences have been had by the several branches of the inter-national association this is the first time in the history of the organization, which was founded in 1875, that the four great branches of the work have been repres-ented at such a meeting.
