

## BAIL REQUESTED FOR MRS. BRADLEY

Poor Health is Given As Cause And Arguments Will Be Heard On Monday.

### OPERATION IN SALT LAKE.

It May Be Made the Basis of New Line In Defense of Senator Brown's Slay.

Washington, July 11.—A petition for admission to bail was filed in the supreme court of the District of Columbia today in behalf of Mrs. Annie M. Bradley of Utah, under indictment on the charge of murdering former United States Senator Arthur Brown. The petition alleges poor health. Arguments will be heard next Monday.

From Washington comes additional sensational news of developments in the Bradley case. It is asserted that Mr. Anna Bradley, who shot and killed former Senator Arthur Brown of Utah in Washington, has confessed that she submitted to a criminal operation in this city. She says she did this at the request of Senator Brown. The jail physician, Dr. D. K. Shute, made an examination and he is quoted as saying he found undisputable proofs of the truth of the prisoner's assertions. Dr. H. L. E. Johnson, a prominent surgeon, was also called in and he announced that an operation is imperative. Steps were then taken to remove the little woman from her cell to the Providence hospital. Here she will spend a month or so. The operation will be performed just as soon as arrangements can be made and a month's rest and quiet will be needed to furnish her with strength enough for the ordeal of trial next October. Dr. Johnson will perform the operation which will be very delicate and important.

#### DOCTOR'S VIEWS.

In his report to the jail authorities Dr. Shute said in part: "Some weeks ago, at your request, I had occasion to make an examination of Mrs. Bradley, with a view of ascertaining her present physical condition. I find that she had a badly lacerated cervix, which I thought ought to be operated on. I still am of the opinion that this operation would very materially improve the health of Mrs. Bradley. As you are aware, we have no facilities in the jail for performing a serious and important surgical operation, and if this operation is to be performed it ought to be done in some hospital. I respectfully request your attention to the enclosed letter from the attorneys of Mrs. Bradley."

Rumor has it that the defense will use this new evidence to show that the worry and mental anguish suffered by Mrs. Bradley before the operation and the addition of physical torture afterwards constituted one of the main reasons for her becoming temporarily insane.

Willard Hanson, county attorney, is keeping the wires between Salt Lake and Washington hot in order to learn the name of the physician or physicians who performed the criminal operation and some startling developments may be expected in this city.

## BOXTON ADMITS HIS CORRUPTION

San Francisco's Temporary Mayor Tells of His Debauchment By Theodore V. Halsey.

### GOT FIVE THOUSAND DOLLARS.

Service, Voting and Using Influence as Supervisor Against Granting Franchise to Home Telephone Co.

San Francisco, July 11.—Dr. Charles Boxton, the temporary mayor of San Francisco, on the witness stand in the Glass trial this afternoon, told the story of his debauchment by Theodore V. Halsey, the indicted agent of the Pacific States Telephone company, who, as testified, paid him \$5,000, "mostly in \$100 bills," for having voted and used his influence as a supervisor against the granting of a rival franchise to the Home Telephone company. The cross examination of Mayor Boxton was scarcely under way when District Atty. Langdon interrupted at 4:30 p. m. to ask an adjournment to permit Boxton to attend "a very important meeting of the board of supervisors called for 3 o'clock." Judge Lawlor consented after it appeared that President Henry T. Scott of the Pacific States company, the next witness on the prosecution list, was not in attendance, though he had been specially summoned.

"I wish it distinctly understood," the judge said, "that any witnesses who are absent when court opens at 11 o'clock tomorrow, will be brought here by process. No witness will be excused from attendance, no matter who he is or what are his business engagements, without the special consent of the court."

The first and only important question asked of Dr. Boxton in cross-examination before he was excused, brought out the answer that the supervisory caucus at which a majority of the 18 supervisors decided to abandon the Pacific States Telephone company—by whom, according to their confessions to the grand jury, they had been bribed to vote a franchise to the Home company, was held in the office of Mayor or Schmitz, on the Sunday evening preceding Feb. 2, 1906. Boxton's cross-examination by Delmas will be resumed tomorrow morning.

Atty. William Thomas of the law firm of Thomas, Gerstle, Frick & Beedy, was the first witness called by Mr. Halsey.

Mr. Thomas said that as attorney for the Home Telephone company of San Francisco, he drew up that corporation's application for a telephone franchise competitive with the Pacific States company's. The original of this application was filed with the clerk of the board of supervisors, and a copy was kept by the witness. Both, he said, were destroyed in the April fire, but he could give the jury the full substance of the matter contained. He proceeded to do this by reading an application made to the Berkeley city government, which, he said, was a copy of the San Francisco document.

One of the vital allegations in the indictment is that this application was pending in the board of supervisors when the alleged bribe of \$5,000 was paid to Boxton to vote against it. To prove his pendency Halsey asked

Thomas if he appeared before the board in support of the application between certain dates prior to the time of the alleged bribery. To this question Delmas objected at length, desiring as he does, to establish the contention that at the time the money was paid to Boxton the application was not legally pending—hence that no vote relative to it could have been influenced, therefore no bribery was committed.

"The element of bribery," ruled Judge Lawlor, "is the influencing corruptly of a public official in the performance of his public duty. Therefore the testimony is admissible as tending to show the circumstances involved in the corruption."

Mr. Thomas answered that he appeared before the public utilities committee of the board, and that Boxton was present. Cross-examination by Delmas was very brief and added nothing.

Chief John H. Ryan of the board of supervisors, who temporarily supplanted Dr. Boxton on the stand yesterday, was recalled, but he was excused without question. Delmas suggesting his willingness to stipulate official publication of the actions of the board with reference to the granting of the home company's application. To arrange this stipulation, Halsey asked a noon adjournment at 12 instead of 2:30 and Judge Lawlor reluctantly consented.

Juror Ponda, who represents eastern manufacturers, made an unusual request of the court. He said it would greatly facilitate his business if he were allowed to have a typewriter at the Fairmont hotel—where the jury is quartered—and take care of his correspondence during the progress of the trial, and he hazarded the guess that the trial will be long and drawn out.

Judge Lawlor said there could be no possible objection to this.

Some time was consumed at the afternoon session by the reading into the record by Asst. Dist. Atty. Ogara of published legal notices of supervisory proceedings relative to the consideration and granting of the Home Telephone company's application.

These published notices show that among other things, that on final passage of the ordinance Supervisors Box-

ton, Sanderson and Walsh voted "no," that is, they stood by the terms of the alleged bribe paid them by the rival telephone concerns; and that Supervisors McGustin and Rea asked to be excused from voting and were excused. The other 13 supervisors voted for the passage of the ordinance.

### OKLAHOMA'S CONSTITUTION.

Fourteen Important Changes by the Convention.

Guthrie, Okla., July 11.—Fourteen important changes in the constitution for the proposed state of Oklahoma were made by the convention this morning. The most important one modifies the initiative and referendum provision by eliminating the section allowing the governor to take means to put into effect another law in event of the legislature's refusal to act upon it. Another vital change eliminates the plank forbidding foreign corporations to appeal from the decisions of state courts. Another amendment gives home railroads the right to merge, but denies the prerogative to foreign corporations. Other alterations affect the appropriation, habeas corpus provision, court fees, or of contempt, religious tolerance, suffrage rights and election of the state board of agriculture.

### FIGHT WITH NEGROES.

One Policeman Killed and Another Probably Fatally Wounded.

Pittsburg, July 11.—In a fight between negroes and policemen at East Pittsburg shortly after midnight this morning, one policeman was killed and another was probably fatally wounded. The dead man was Patrick Sullivan. It had been decided to raid a negro resort in the rear of a place in Linden avenue. When the officers broke in upon the men gathered there, the negroes began shooting. Officer Sullivan fell with a bullet in his head and died a few minutes later. Another officer whose name could not be learned, was also struck by a bullet and was hurried to the Bradlock general hospital. A negro who is suspected of having fired the fatal shot, was arrested and was taken to the Bradlock lock-up in order to await developments.

### LUMBER MILL DESTROYED.

Portland, Ore., July 12.—A special to the Oregonian from Cascade Locks, says:

Fire which originated in the boiler room of the plant destroyed the Wind River Lumber company's mill at Cascade Locks and driven by a heavy wind, the flames consumed every building between the mill and the river. The loss is over \$150,000. Telegraph poles were burned and the wires prostrated. The railroad train for Cheyenne, which was delayed several hours.

### JUMPED THROUGH WINDOW.

Escaped from Denver Reached Cheyenne, Surrendered Because Injured.

Denver, Colo., July 11.—John T. Thompson, a criminal, arrested by Detective Joseph Day of the Portland, Ore., police department, leaped from a car window while the train was running at a speed of 40 miles an hour near this city today and escaped. Thompson was wanted at Portland to answer a charge of stealing \$3,000 and was captured in London, England, after a chase around the world.

Search for Thompson was kept until late tonight when word was received from Cheyenne, Wyo., that the escaped prisoner was in custody there. Thompson managed to work his way back through the railroad yards of this city to the Union depot and boarded a north-bound train for Cheyenne. Before reaching the latter city he gave himself up to the conductor, saying that his injured shoulder pained him so much that he could stand it no longer. On reaching Cheyenne, Thompson was taken into custody by the police there and given medical treatment. He will be held until the arrival of Detective Day of Portland, from whom he escaped today.

### OMAHA CHINAMAN MURDERED.

Omaha, Neb., July 11.—Robbers last night fatally beat Han Pak, a Chinese restaurant keeper, and robbed his strong box of \$100 in cash. An ice-man found Pak lying in a pool of blood in his kitchen at noon and notified the police. He was removed to a hospital, where he died two hours later. A bloody meat cleaver and a pick handle gave evidence of a terrible struggle, during which the Chinaman received a score of deep wounds, several on his head, resulting in death. There is no clue to his assailants.

### KNIGHTS TEMPLAR ADJOURN.

Saratoga, N. Y., July 11.—The grand encampment of Knights Templar voted today to hold its next triennial convocation in Chicago in 1910.

The convocation concluded today with the election of the following officers: Henry W. Rugg, Providence, grand master; William B. Melish, Cincinnati, deputy grand master; Arthur MacArthur, Troy, N. Y., grand generalissimo; Frank W. Pierce, Oakland, Cal., grand captain-general; H. Wales Lines, Meriden, Conn., grand treasurer; John A. Gerow, Detroit, grand secretary.

Grand Master Rugg appointed George C. Rafter, Cheyenne, Wyo., grand prelate; William H. Norris, Manchester, Ia., grand standard bearer; J. W. Chamberlain, St. Paul, grand squire; Frederick C. Thayer, Portland, Me., grand warden.

### FRANCIS MURPHY'S WILL.

Los Angeles, July 11.—The will of the late Francis Murphy, "apostle of temperance," was filed today for probate. Mr. Murphy, according to the petition, left an estate valued at \$20,000. His home in this city, valued at \$5,500

and \$1,350 on deposit are bequeathed to his widow. The remainder of his estate was divided in equal parts between the widow and children of the evangelist.

### CATHOLIC EDUCATORS.

Elect Cardinal Gibbons Honorary President of Their Association.

Milwaukee, Wis., July 11.—Cardinal Gibbons was today unanimously elected honorary president of the Catholic Educational association. Rt. Rev. D. J. O'Connell, D.D., of Washington, D. C., was elected president-general. Rev. F. W. Howard of Columbus, O., was chosen secretary-general. Members of the general executive board are: Very Rev. J. A. Burns, Washington, D. C.; Rt. Rev. Mgr. John M. Mackey, Cincinnati; W. J. Shanley, Denver; Father Peter York, San Francisco; Very Rev. J. A. Connelley, St. Louis.
