EVENING NEWS.
BY TELEGRAPH.

The House of Representatives, about nine o'clock this evening, it was placed on the Speaker's table and remained there two hours unopened and without any announcement of the contents of the envelope, until the pending bill for the establishment of a national board of health was disposed of. A motion to proceed to the business on the Speaker's table then prevailing, Speaker Randall laid the veto message before the House as the matter of the highest privilege thereon, and it was read from the clerk's desk.

Most of the negative votes came from the republicans of the House, but a considerable number came also from the democratic side. The private comments upon the message made by members who listened to the reading were generally adverse to its being considered a strong document, though, of course, the criticisms are more or less colored in each instance by individual views upon the main question involved.

Senator Sargent, after perusing the copy of the veto message, which was sent to the Senate, but of course not read in that body, as there was no occasion to vote upon it, commented upon it in the following emphatic terms, which are reported verbatim.
