WASHINGTON, 28.—Col. J. W. Grimes, Secretary of Senator Jones of Nev., died in this city to-day, of pneumonia after a brief illness.

The Chorpenning Case.

The court of claims to-day rendered a decision in regard to the famous Chorpenning claim. It was contended that the reference of this claim by Congress to the Paymaster General had his decision that between four and five hundred thousand dollars were due to him as the claimant, constituted an award binding on the government. The court now sustains a demand upon this amount, and has directed that nothing further be done in this case by the government. An appeal will be taken to the supreme court.

Notes Retired—Confidential Communication from the Attorney General.

The Sherman Act will to-morrow take up the Illinois tax bill.

The Secretary of the Treasury has directed the retirement of \$22,748 in U. S. notes, being eighty percent of the new national bank currency issued during this month.

This bill leaves the amount of the national bank circulation until further orders, \$31,000,000, to Feb. 28.
