THE NEWARK BANK.

NEWARK, N. J., Nov. 1.

Baldwin was arrested in bed at 7 o'clock this morning.

He showed no surprise, and was

evidently expecting arrest. He

said he would not give bail, and

was content to pass his life in

prison.

"I shall never be seen on Broad

Street again," he exclaimed. "The

business of the Newark Bank of

Nugent & Co. is said to amount to

\$100,000 a year. They employ 600

men, and their weekly payroll

amounts to \$40,000. When Bal-

dwin was before us," said a director

to a Tribune reporter, "he appeared

as a man of clean breast and

honesty. He said he had no

idea what he had done, and admitted

A Significant Circumstance.

Shortly after the last statement

of the Newark bank was published,

a peculiarly fitting illustration of

the officers of the Newark

Bank of this city. It was

observed at once by officers

of other banks, that the officers

wondered at the statement, but

could not prove it false. This pecu-

liarity was the large amount due

from correspondent banks, amount-

ing to \$100,000. The officers of the

correspondent bank in New York to

which the Newark bank was then

indebted about \$100,000, sought an

explanation of this item from the

cashier. Baldwin's explanation was

that the money belonged to the

Mutual Benefit Life Insurance com-

pany of Newark; that the bank was

paying a small rate of interest on
