Sheets and myself called to see C. W. Millard, when I asked him the following questions: "Are you satisfied with the judg-

ment of the court and the treatment of the Sheriff and guard?" He answered abruptly, "Yes, sir!"

2nd. "Have you no feeling of regret for the killing of Mr. Swett, and are you not pleased that Mr. Mayfield got out of your reach?"

"I am glad that Mayfield got away." 3rd. "Have you any hopes or fears respecting the future state you are about to enter upon?"

"I do not understand what you mean," he replied; and then said, "I sleep as good and better, than before. I dream a great deal, and imagine myself flying in the air. I used to dream during the war that the rebels were chasing me and I could feel myself rising and flying in the air out of their reach." After other remarks in this style, he asked me "if it was 10 o'clock," and said "I shall soon get out into the fresh air; and you bet, if it is to come, the sooner the better."

"Will you give me your correct name, that which your mother taught you?" "Chauncey W. Millard."

5th. "Can you name any friend or relative with whom you would wish us to correspond or have you any word to leave for

them?" "I have nothing to send to any relative or friend; if they find it out by the public papers or any way, all right; but not with my consent."

6th. "Have you heretofore felt an inclination to destroy life?.'

"Never had any satisfaction in killing; neither in the army nor since. Felt once before like murdering but it amounted to nothing. The feeling came over me twice to kill Swett before doing the deed. Had no feeling and knew nothing against Swett. I have nothing resting on my mind or would tell it." out the most sent them

He further remarked. "I was in hopes I would die with these irons off. I am glad I am going where there is none of these things." Becoming jocular with the guard he said, "When I get up there, I will keep a place for you in the 2nd gallery on the right side."

He then looked out of the window, and seeing the crowd of people, said, "What do all these want out there. I suppose to see the elephant!" As the snow was falling: he said "It was snowing like this when done it."

At 25 minutes to 11 o'clock he was taken from prison to the place of execution; but 1 need not dwell on that as the details have already been published.

From a sketch of his history taken by Bro. Noon, it appears that he was born in with such co-laborers as I now have." the State of New York, about the year 1851; that his father deserted his mother when he was about two years old; that his mother worked for and supported him until he was about six years old, and then he had to go into the poor house, staying there about one year. He was afterwards in the male Relief Society of that ward. It was employ of a farmer named Babbitt, who treated him harshly, and from whom he ran away. He then rambled from one place to another, committed several robberies and was engaged in various pursuits, finally following the 8th Michigan Infantry into the Southern States, and by running messages and purchasing for the soldiers, etc. he accumulated about three thousand dollars. He went back with the regiment to Detroit, Michigan, and traveled about a good deal, principally in Canada, and eventually went to Grand Rapids, Mich. His money being all gone, he went to Lyons, Iowa, and then made up his mind to go to Salt Lake City; but was detained some time through sickness. He came on afterwards to Omaha, thence to Bryan and from there to Salt Lake City, where he engaged to go to White Pine district with Mr. Mayfield, whose teamster, H. P. Swett, he murdered, learning that Mayfield had about \$600 in cash, which he desired to obtain. A day or two ago while the guard was washing him they found tatooed on his right alwolled and all the state of the state
