Trustees Elected.—Last evening a meeting of the tax-payers of the Ninth School District was held in the Schoolhouse, for the purpose of electing three trustees, to hold office for the ensuing term.

Association.—The members of the Young People's Mutual Improvement Association of the Second Ward met last evening, and re-organized. The officers are: William L. Departed.—Mrs. Nuckolls, wife of Col. S. F. Nuckolls, died last evening at her residence, in the 18th Ward. Her husband, who was absent in the Sweetwater country, was telegraphed to the other day, regarding the critical condition of his wife. He is expected to reach home this evening. The deceased had the reputation of being a most estimable lady, universally respected by those acquainted with her. The cause of death was general debility.

Suspected Sheep Poisoning.—A little over a week ago the West Jordan sheep herd was taken to the head of Three Mile Cañon, east of Parley's Park, when some of the animals died suddenly. The herder, thinking some poisonous weeds were the cause, moved the flock, a week ago to-day. Mr. Samuel W. Egbert, of West Jordan, took his sheep herd to the same locality, and in a little over two days he lost 150 head. He suspects that poison had been purposely strewn on the ground by some maliciously disposed persons.

They fled to the adjoining hills, pursued by the doughty Mark, for whom, however, they proved, too fleet of foot, getting clear and secreting themselves in the surrounding brush.

Compendium.—Elder James A. Little is now engaged in compiling materials for a doctrinal concordance or compendium, with a view to publication. In 1857 a work of a similar character, entitled, "A Compendium of the Faith and Doctrines of the Church of Jesus Christ of Latter-day Saints," compiled by Elder Franklin D. Richards, was published at Liverpool. It has been of great service to the Elders, especially those actively engaged in missionary labors abroad, but is now out of print. Elder Little commenced his labors in compiling materials for the proposed work by direction of the late President B. Young, and it is intended to make it as comprehensive and complete as practicable. It is a book that is greatly needed and for which there is likely to be a lively demand when it is published. The collection and preparation of the materials require much study, patience and research, and it will therefore be some months at least, before the book will make its appearance.

Jubilee.—The Sunday schools of Weber County are divided into three districts for musical purposes, under the direction respectively of Professors Fowler, Pugh and Ellis. This arrangement was made in consequence of the Ogden Tabernacle not being sufficiently spacious to accommodate the children of the combined schools of the whole county on the occasion of a jubilee.

The districts under the musical superintendency of Professors Fowler and Pugh had each a jubilee at Ogden, some time since. That in charge of Professor Ellis, of North Ogden, had its musical festival, at the same place, yesterday. The exercises were highly creditable, and the occasion was a most pleasant one. During the course of the entertainment brief addresses were delivered by Elder Richard Ballantyne, County Superintendent of Sunday Schools, Mayor Farr, Elder David M. Stuart, and President L. J. Herrick.

After the exercises at the Tabernacle the children adjourned to the Grove. The proceedings wound up with a social party at the Ogden City Hall, in the evening.

CORRESPONDENCE.

SUNSET, August 4, 1877.

Editors Deseret News:

When I arrived at Elder Lot Smith's camp a little over one year ago I found his people living in their wagons under a bowery close on the margin of the Little Colorado River. This was not a suitable place for a permanent settlement, so we moved to where our fort now stands. We have built quite a number of houses besides a large hall over fifty feet in length and about sixteen feet wide. We have a blacksmith's shop, corrals, stack yard, and many other good and substantial improvements. Our land was all covered with a thick growth of rabbit and grease brush, and large dry cottonwood logs, that had fallen to the ground, intermixed with large quantities of drift wood from the river. We have cleared many acres of land and sown and planted wheat, corn, squash, melons, sugar cane, and a large variety of garden vegetables, all of which have done well, considering the chance they have had. We think we shall have about 600 bushels of wheat, and about the same amount of corn. We have some of the largest squash I ever saw. Our melons are excellent, our cane is getting ripe and we shall soon commence making molasses. Our wheat is all in the stack, we are cutting and hauling our corn into the yard.

Brother Ballinger's fort is a little more than one mile west of ours. They have had good crops of wheat, corn and several varieties of vegetables. Brothers Jackson and Blinky have been to the timber country, and made a molasses mill. Brothers Jackson, and Garus have put the mill together, and it is now running night and day, grinding cane for Bro. Ballinger and making a first-rate article of molasses, clear as honey.

Our grist mill has arrived, and we are going to commence building a foundation at Brother Ballinger's dam, close to the river, on which to erect a house for the machinery. So if all's well we shall soon have a flour mill in active operation.

Brother Hartley, an experienced lime burner, with others to assist him, has been to Sunset Pass and burned a kiln of lime, for mortar for the mill foundation. So you see that we are progressing slowly but surely. By the help of the Lord we are going to make a success of this mission. We want now to be properly organized into the United Order, and then we are bound to prosper. We are trying to work in order. We should have one organization for all the camps or settlements.

A military officer was at our camp yesterday; he was much surprised to see the great amount of work we have done in so short a time. We need some more good Latter-day Saints to join us, we need a good shoemaker, Brother Ballinger needs a good blacksmith. Any and all other good faithful saints that are willing to live in the United Order; those who do not want to live in that order had better not come out here.

God bless and prosper you and all Israel is the prayer of your brother in the New and Everlasting Covenant.
